Parallel teams should be engaged in all the cities and the work should be taken up as a challenge and completed successfully

3. Agenda: UTILISATION OF REFORM INCENTIVE

The State of Kerala was awarded with an incentive for obtaining more than 70% score for implementing mandatory reforms for FY 2015-16 under AMRUT. Vide MoUD OM No K-16012/3/2016- AMRUT II, the Ministry has released Rs 15.00 Cr for the achievement of the reform milestones. As per the general guidelines regarding reform incentive from MoUD, the SHPSC may decide upon the utilization of the incentive amount.

After deliberations, the Committee decided to retain an amount of Rs. 3.00 Cr at the State Mission Directorate and to utilise the amount for various feasibility studies. The remaining, Rs.12.00 Cr may be distributed among the Mission cities based on their performance in achieving the reform milestones (40%), population (30%) and project allocation (30%). The incentive allocation based on the stated formula to the Mission cities is given below

4. Projects proposed under Sewerage/Septage Management, SAAP 2017-18

The 8th SHPSC held on 24th January 2017 has suggested to revisit the projects proposed under Sewerage / Septage Management for SAAP 2017-18. Therefore, it was decided to discuss with the Mission cities about the rationale for proposing various projects and to further select the most feasible project in each of the Mission cities. The prioritised projects proposed by Mission Cities for SAAP 2017-18 & the list of approved projects under SAAP 2015-16& 2016-17were discussed in detail and following decisions were taken.

a. Thiruvananthapuram

The Corporation of Thiruvananthapuram has proposed 14 projects in various wards aiming to connect with the Centralised Sewerage Treatment Plant at Muttathara. However, the Chairman suggested the CMMU to study the proposals & to find if the proposals were the same as earlier proposals in other projects under KSUDP, and JnNURM. If so, to reason why these proposals were not completed earlier and later included in AMRUT. CMMU shall also look into the immediate benefit of the proposals including their cost benefit analysis.

A separate meeting of the Engineering staff of the Corporation, the PIU of KSUDP and CMMU members, in the presence of the Mayor of the Corporation shall be convened to discuss the technical feasibility and economic viability of these projects and to assess if all these proposals can be completed within the AMRUT mission period. An official from KWA shall be responsible for the implementation of these proposals.

b. Kollam

The projects proposed by the Kollam Corporation were assessed and enquired if the land is available for the construction of the Treatment Plant. The Chairman directed the CMMU of Kollam to discuss the proposals with the PIU,KSUDP and Officials of Engineering Department on the availability of encumbrance free land and to give clear information on all the projects proposed, its viability and status of all environmental clearances. The proposals shall be clearly denoted in a map, showing the STP and the networks.

A workable plan shall therefore be developed in discussion with KWA by using the infrastructures that are already in place. The ULB shall also obtain road cutting permissions where ever required.

c. Alappuzha

Three projects are proposed under AMRUT for decentralized sewerage management system. The committee approved the projects and directed to proceed with DPR preparation.

d. Kochi

The projects proposed for SAAP 2017-18 were approved by the SLTC. However, it was suggested to rework the project for Rejuvenation of Sewerage Treatment Plant at Elamkulam approved in earlier SAAP 15-16. Also, the Chairman suggested to consider constructing a new sewerage plant of 5 MLD or optimal capacity without adding new networks, instead of rejuvenating the old ones.

For the projects, Land availability shall be ensured by CMMU, Kochi and Sri. Sahuji (EE, Kochi Corporation). The projects including the engineering design shall be taken up by KWA on an EPC mode.

e. Thrissur

The Committee noted that the proposals from Thrissur are for Storm Water Drainage treatment, hence it was not approved by the Committee, as the same cannot be included under the Sewerage Sector.

The Chairman suggested to Hon. Mayor of Thrissur Corporation to rework towards Decentralised Sewerage & Septage Treatment plants for the ULB, based on the availability of land.

OTHER ITEMS

5.1 Selection of Consultants

It is decided that the consultants for DPR preparation have to be selected from empanelled agencies through competitive process. It is essential that the agencies have prior experience in working with the ULBs. It is also directed that the ULBs need to make sure that the technical and managerial personnel proposed in the bid proposal will be working in the proposed project once the consultant is selected.

Information on all the empanelled agencies, which have come out as GO's from LSGD, Finance Department and Proceedings of Suchitwa Mission should be uploaded in the SMMU website (www.smartkeralamission.org)

Also decided that there should be consistency in matters communicated by SMMU to the ULBs regarding AMRUT Mission and its implementation. All relevant information of AMRUT in Kerala shall be uploaded and updated regularly in the website of SMMU under AMRUT link and it is better to have a dedicated website for AMRUT.

5.2 Change of Project

The Chairperson of Guruvayur requested to allow a change in the project for the city. She suggested that a desalination plant be permitted and approved for the city. In this context, the SLTC Chairman suggested to take up the project under EPC mode. It was also suggested to study how desalination plants have been set up in Chennai. He also urged the ULBs to think of innovative ideas to provide water supply for the citizens like putting up large capacity SMC (Sheet Moulding

Compound) water tanks (Capacity based on population) near water sources identified. These can be make shift tanks which can be used elsewhere as and when need arises.

5.3 Engaging KMRL in Urban Transport

The Mission Director, informed that the Mission Directorate had a preliminary meeting with KMRL and they have agreed in principle to take up the design & implementation of Urban Transport Sector projects (end to end support) in all Mission cities. However, the KMRL have proposed a consultancy fee at an average of 7% to the total project cost for their end to end support.

The representatives from the Mission cities opined that the rate quoted by KMRL is on higher side. Further, Chairman suggested that the prevailing government norms be referred. Also, it was decided that the ULBs shall be given the freedom to select the agency for DPR preparation or both design and execution of the project. KMRL's support may be finalized only upon the willingness of both ULB and KMRL to take that particular assignment.

For Multilevel parking projects, it is suggested to explore the possibility of Public Private Partnership and to seek the support of Partner Kerala Mission.
