AMRUT REFORMS 2016-17

The Mission envisages improving governance through a set of Reforms. For 2016-17, Kerala State has received an incentive amount of Rs.16.68 Cr after the evaluation by the Ministry of Urban Development of the self assessed score card of Reform milestones along with all supporting documents. The score card is enclosed as *Annexure –ii*. Milestones remaining which require decision at the State level are

- Establishment of Municipal Cadre
- Appointment of internal auditor
- Adoption of Model Building By-Laws- 2016

CONSTITUTION OF A MONITORING AND REVIEW COMMITTEE FOR FORMULATION OF GIS BASED MASTER PLAN FOR AMRUT CITIES.

GIS based Master Plans for AMRUT cities is one of the Sub scheme of AMRUT and is fully funded by MoUD. In Kerala, Town and Country Planning Department(TCPD) is designated as the nodal agency for the scheme. The State had submitted a State Action Plan (SAP) to MoUD for the formulation of GIS based Master Plans for AMRUT cities with the approval from the State Level High Powered Steering Committee held on 9th May 2017.

MoUD has directed vide letter F.No. 2/16(18)/AMRUT/URIS/TCPO dated 15.6.2017 to constitute a Monitoring and Evaluation Committee at State Level to review the progress of master plan formulation. The funds / installments for the sub-scheme will be released by MoUD only on the recommendations of the Monitoring and Evaluation Committee whose suggestive composition is given below.
