Agenda Item No. 1. Approval of the Minutes of the 7th SLTC held on 16.06.2017 and the 8th SLTC held on 28.06.2017.

Decision

The SLTC approved the Minutes of the 7th SLTC held on 16.06.2017 and the 8th SLTC held on 28.06.2017.

Agenda Item No. 2. Action taken report on the decisions of 7th and 8th meeting of SLTC

2.1 Administrative sanction for DPRs

The 7th SLTC held on 16.07.2017 had reviewed 16 DPRs worth Rs 120.54Cr from three mission cities viz. Thiruvananthapuram, Kochi and Guruvayoor and recommended to place them before the next State High Powered Steering Committee (10thSHPSC) for Administrative sanction. Similarly, another 4 DPRs worth Rs 23.16 Cr. in Urban Transport sector from Palakkad Municipality has been recommended to the SHPSC by the 8th SLTC held on 28.07.2017.

2.1.1 Action taken

Total 20 projects amounting to Rs.143.70 Cr have been recommended for AS to the 10th SHPSC to be held on 14th July 2017.

2.2 HR support for KWA

The 7th SLTC decided not to give any consultancy fee to KWA for preparing DPRs in water supply and sewerage sectors, but to reimburse cost on actuals upon the submission of bills for all types of surveys carried out during DPR preparation. Also, HR cost of Rs.33.25 lakhs from AMRUT A&OE was sanctioned to develop and maintain web based monitoring portal for water supply projects under AMRUT

2.2.1 Action taken

Mission Director has initiated the process of releasing payment of Rs.33.25lakhs to Managing Director, KWA from AMRUT A&OE funds for survey works and monitoring system.

2.3 Credit rating of mission cities.

SLTC decided to call for a special meeting of the Secretaries of the Mission Cities chaired by the Director-Urban Affairs, to discuss the implications of the credit rating & its follow up action and further to place it in the SLTC.

2.3.1 Action taken

Director, Urban Affairs has scheduled a meeting with the Secretaries of Mission cities during the third week of July 2017 to finalise the follow up action.

2.4 AMRUT reforms 2016-17.

The Director of Urban Affairs suggested to Team Leader SMMU to submit a note on the reform milestones of 2016-17

2.4.1 Action taken

Team Leader SMMU submitted a note regarding AMRUT reform milestones of 2016-17 to the Director Urban Affairs.

Decision

The committee took note of the action taken report of SLTC meeting

Agenda Item No. 3. Administrative sanctions to the projects

The Mission Directorate has received 61 projects amounting to Rs.156.63 Cr from five mission cities viz. Kollam , Alappuzha, Palakkad, Thiruvananthapuram and Kochi.

SLTC reviewed each project placed for AS in detail and the comments are enclosed as *Annexure1*. The committee decided to recommend 40 projects amounting to Rs. 121.13 Cr for the consideration of SHPSC. Remaining 21 projects amounting to Rs.35.5 Cr to be reworked. Agenda Item No. 4. CHANGE OF PROJECTS APPROVED IN SAAP

Municipal Corporation of Kozhikode vide letter No. EG-12/30199/16 has informed the Mission Director that a multi level parking complex at Stadium Junction amounting to Rs.14.12 Cr proposed in SAAP 2016-17 under Urban Transport has been cancelled as ULB decided to develop it through PPP model (BOT). Subsequently, the council approved the cancellation of project from

Urban transport and to transfer the project cost to Sewerage Sector

for the project – Construction of sewerage system in Zone A.

The SLTC observed that as per the guideline of MOUD in case of cancellation of projects, new projects may be taken up only in the priority sectors of AMRUT ie., Water Supply and Sewerage and Septage Management Sectors. Hence SLTC decided to consider the

Agenda Item No. 5. SELECTION OF CONSULTANTS

As per the decision of 5th SLTC, the Mission Cities were directed to select consultants for DPR preparation from the list of consultants empanelled by LSGD under various projects/programmes.

5.1 In Guruvayur, for Urban transport sector, consultants outside the empanelled list also participated in the open tendering process. The municipality has selected M/s Muralee Associates as consultant at a fee of 1:1% fixed as consultancy fee. The council has approved the selection of the consultant

SLTC observed that ULB has selected the consultant through Competitive bidding process and all the procedures for consultant selection had been followed by Guruvayur municipality. The consultant who quoted the lowest rate of consultancy fee of 1.1% of DPR is selected for the assignment. Therefore, SLTC ratified the selection of M/s Muralee Associates for the preparation of DPRs in Urban transport sector.

5.1.1 In Kannur, despite of repeated tendering in Open spaces and parks sector, no response was received from the empanelled consultants. Hence the municipality has sought permission to entrust Steel Industries Limited Kerala(SILK) who have expressed their willingness to take up the DPR preparation in Parks sector

SLTC deliberated on the profile of SILK and directed the corporation of Kannur to review the technical competence of SILK in the park sector and the criteria for evaluation shall be.

The consultant shall have minimum of 3 years of experience in preparing the DPR for parks. with a project cost not less than 50% of the project cost of proposed parks projects in Kannur under AMRUT.

The supporting documents showing the experience of SILK in park to be submitted along with photos and certificate of completion from the respective clients

- 1. Need of the project/rationale to be ascertained
- 2. Expected impact/ result and change in the benchmark
- 3. Contour Map showing the entire drainage network within the ULB limit
- 4. Drainage network map along with road network
- 5. MSL data in all major network points
- 6. Annual Rainfall data of the city and water shed pattern
- 7. Last receiving Tail ends capacity with depth, width and discharge in kilolitre/min to the main drain.
- 8. Primary drains carrying capacity assessment
- 9. If primary Drain is discharging to any National waterway, possibilities to converge with the proposal of other agencies like KSINC(Kerala State Inland Navigation Corporation) etc to be proposed.
- 10. Provisions/ proposals to prevent Flooding/ maintain the quality of water.
 - a. Side wall protection
 - b. Strategies to maintain the width and depth on entire length(desilting).
- 11. Provisions/ proposals to maintain the quality of water.
 - a. In case, Grey water/Black water/other Liquid waste/Solid wastes if disposing/mixing with the drainage, then the provisions to treat these discharges before letting it out to the storm water drain. The details of treatment technology to be an integral part of the DPR.
 - b. Strategies to prevent the disposal of solid waste to secondary and tertiary drains
 - c. Details of encroachment and strategies for rehabilitation
