ORDER

As per the order read as 1st paper above, Administrative Sanction was accorded for the work "Construction/rejuvenation of Drains - sub work - Construction/ Rejuvenation of Padanna Phase-II" for an amount of Rs 11.13 Cr, under Storm Water Drainage (SWD) sector.

The 23 rd SHPSC of AMRUT held on 4/2/2020 had accorded sanction for tender excess of 9.89% (Rs 19.36 lakh) for the work, "Construction / Rejuvenation of Drains – sub work – Construction / Rejuvenation of Padanna Phase-II" being implemented by Kannur Corporation.

As per the letter read as 3rd paper above, the Mission Director AMRUT has informed that there were no bidders for the first tender which was on 22.10.2019 . Two bids received on the 2nd tender on 5/11/2019 were rejected by the council as the quoted rates were 14.8% & 20% above the estimate rate and the council decided to re-tender. In the 3rd tender held on 2/11/2019 the amount quoted by the single bidder was 9.89

% above the tendered PAC, which is within the T.S. amount. As the work is to be executed in the main city & market premises in Kannur facing public protest and traffic congestion, there is no scope for a better offer and as such the Kannur Corporation council has recommended the tender excess.

Government have examined the matter in detail and pleased to approve the tender excess of 9.89% (Rs 19.36 lakh) above the tendered PAC for the project “Construction / Rejuvenation of Drains – sub work – Construction / Rejuvenation of Padanna Phase-II” being implemented by Kannur Corporation, based on the decision of the SHPSC.
