ORDER

As per Govt. Order read as 1st paper above Administrative Sanction has been accorded for the project "supplying and erection of pump set, transformer and electrical accessories in Block L Edathara Pumping Station" in Thiruvananthapuram Corporation for an amount of Rs 1.80 Crore, under AMRUT. While preparing detailed estimate for Technical sanction, it was noticed that the capacity of transformer, generator etc. has to be enhanced, resulting to an increase of cost to Rs. 4.0 Crore. The 21st meeting of State level High Powered Steering Committee (SHPSC) of AMRUT held on 27/02/2019 has decided to accord revised Administrative Sanction to the project for Rs 4.0 Crore, vide minutes read as 4th paper above.

2.As per Govt. Order read as 2nd paper above, Administrative Sanction was accorded for the project "De-centralised sewage and septage treatment plants and associated sewerage networks for Zone A in Kozhikode Corporation" for an amount of Rs 106.69 Cr. Due to cost escalation in the final DPR, the Mayor, Kozhikode Corporation has requested to issue revised Administrative Sanction for the project for Rs.116.50 Cr. The 21st meeting of State level High Powered Steering Committee (SHPSC) of AMRUT held on 27/02/2019 has decided to accord revised Administrative Sanction to the project for Rs 116.50 Cr, utilizing the fund from the SAAP savings, i.e. Savings

obtained from the Sewerage Sector projects of Kollam, Kannur and Palakkad.

3.The 21st SHPSC of AMRUT held on 27/02/2019 has also decided to accord Administrative Sanction to the following projects in Sewerage & Septage Sector under AMRUT in Alappuzha Municipality:-

- 10 KLD Mobile Septage treatment plant for Alappuzha Municipality (2 Nos.) - Rs.80,00,000/-
- 15 KLD Sewerage treatment plant at Shathabdi Mandiram in Alissery Ward - Rs.30,00,000/-

4. As per the Note read as 3rd paper above the Mission Director, AMRUT has submitted proposal for issuing Administrative Sanction/Revised Administrative Sanction for the projects mentioned above, as approved by the 21st State level High Powered Steering Committee (SHPSC) of AMRUT held on 27/02/2019.

5.Government have examined the matter in detail and are pleased to order as follows:-

- Revised Administrative sanction is accorded to the project "supplying and erection of pump set, transformer and electrical accessories in the Block L Edathara Pumping Station" in Thiruvananthapuram Corporation for Rs.4.0 Cr.
- Revised Administrative sanction is accorded to the project "Decentralised sewage and septage treatment plants and associated sewerage networks for Zone A in Kozhikode Corporation" for Rs 116.50 Cr, by utilizing the fund from the SAAP savings. (Savings obtained from the Sewerage Sector projects of Kollam, Kannur and Palakkad can be used for this purpose).
- Administrative Sanction is accorded to the project "10 KLD Mobile Septage treatment plant for Alappuzha Municipality (2Nos.)" in Sewerage & Septage Sector under AMRUT for Rs.80,00,000/-.
- Administrative Sanction is accorded to the project "15 KLD Sewerage treatment plant at Shathabdi Mandiram in Alissery Ward in Alappuzha Municipality" in Sewerage & Septage Sector under AMRUT for Rs.30,00,000/-.
