ORDER

As per the orders read as 1st and 2nd papers above, the tender excess of 19.92% above the estimate rate of work - Providing Decentralized Network with STPs in Old Kannur Municipal Area - was approved subject to the condition that half of the cost due to tender excess shall be borne by the Corporation and Council resolution regarding the same shall be obtained by the Corporation Secretary.

2. As per the letter read as 4th paper above, the Mission Director, AMRUT has informed that the Kannur Corporation Council vide resolution No.18 dated 08.01.2021 decided to request the SHPSC to reconsider the decision taken by SHPSC as the tender excess can be met from the TS savings and the matter was discussed in the 20th SLTC meeting held on 17.02.2021 and that Committee decided to consider the request of Kannur Corporation since the project ID is single and includes sewerage networks and road restoration together, the total cost will come well within the TS amount.

3. The decision of 27th SHPSC (No.5.3) is :“The Committee deliberated the matter in detail. It was noted that network and road

restoration are part of the same project (single project ID) and hence overall expenditure is well within the AS amount. However, in case of any additional fund requirement, the Corporation has to bear 50% of the same.”

4. Government have examined the matter in detail and, based on the decision of the 27th SHPSC, are pleased to approve the tender excess of 19.92% without any additional fund requirement as the total cost will come well within the TS amount; subject to the condition that, in case of any additional fund requirement, the Corporation has to bear 50% of the same.


