**ORDER**

As per the order read as 1st paper above Administrative Sanction was accorded for the work "Providing Decentralized Network with STPs in Old Kannur Municipal Area" (SAAP 2017-18) under Sewerage & Septage sector for Rs.46.81 Cr. being implemented by the Kannur Corporation.

2. The Technical sanction (TS) was accorded for Rs.23.6 Cr. Now an excess amount of Rs.3.27 Cr. over TPAC is required due to tender excess of 19.92%.

3. The reason for the excess amount required is due to the facts that contractors were not willing to reduce their quotes and majority of the sewer pipe laying works at a depth of 1.5 to 4.5 m had to be executed in the busy market area in front of the Kannur Railway Station.


4. As per the letter read as 3rd paper above, the Mission Director, AMRUT has informed that the additional fund requirement of Rs.3.27 Cr. will be met from TS savings in the road restoration of the same project.

5. Government have examined the matter in detail. As per the decisionno 5.11 of the 26th SHPSC, Government are pleased to accord sanction to revise the original AS for the work "Providing Decentralized Network with STPs in Old Kannur Municipal Area" (SAAP 2017-18) under Sewerage & Septage sector being implemented by the Kannur Corporation, a tender excess of 19.92%, subject to the condition that half of the cost due to tender excess shall be borne by the Corporation and Council resolution regarding the same shall be obtained by the Corporation Secretary.
