**ORDER**

As per the order read as 1st paper above, Administrative Sanction was accorded for the work “Development of Chelora Park in Kannur Corporation” (SAAP 2017-18) under Park sector, being implemented by the Kannur Corporation for Rs.1.40 Cr.

2. As per the letter read as 3rd paper above, the Mission Director, AMRUT has informed that the Secretary, Kannur Municipal Corporation has submitted the proposal for the revision of Administrative Sanction for the work, “Development of Chelora Park in Kannur Corporation” (SAAP 2017-18) under Park sector, being implemented by the Kannur Corporation, before the 27th SHPSC.

3. The reason for the need for the excess amount required is due to increase in scope of the work. An excess amount of Rs.0.10 Cr. over AS Amount is required for the satisfactory execution of the work.

4. The 20th SLTC meeting held on 17.02.2021 reviewed the same and decided to recommend the revision of AS amount for the work to 1.5 Cr. from 1.4 Cr. (excess of Rs.0.10 Cr.) to SHPSC for approval. The matter was placed before the 27th SHPSC and the decision (No.5.6) of 27th

SHPSC is as follows:


“The Committee decided to accord sanction to revise the AS of the work to Rs. 1.50 Cr. from Rs. 1.40 Cr. subject to the condition that the Corporation bears the extra cost of Rs.10 Lakh.”

5. Government have examined the matter in detail and, based on the decision of the 27th SHPSC, are pleased to revise the original AS of Rs.1.40 Cr. to of Rs.1.50 Cr. (excess of Rs.0.10 Cr.) for the work, “Development of Chelora Park in Kannur Corporation” (SAAP 2017-18) under Park sector, being implemented by the Kannur Corporation, subject to the condition that the Kannur Corporation shall bear the extra cost of Rs.10 Lakh.
