ORDER

As per the letter read as 3rd paper above, the Mission Director, AMRUT has informed that the Rain Water Harvesting (RWH) projects in Kollam Corporation were envisaged to install residential RWH units with a Unit Cost of Rs. 13000/-. The condition was 25% of the unit cost has to be borne by the beneficiary. As per the order read as 1st paper above, AS was issued and the AS amount was Rs.2.667 Cr each for 2015-16 & 2016-17.

2. Though the work was awarded, only 55 applications have been received in place of the needed 4106 numbers for two works. Hence the Corporation Council decided to reduce the beneficiary contribution to 10% of the cost to attract more beneficiaries. When the beneficiary contribution is reduced to 10%, only 3418 beneficiaries will be catered in place of the original proposal of 4106 beneficiaries. The matter was placed before the SHPSC and the following decisions were taken by the Committee.

1. The Committee accorded sanction to reduce the beneficiary contribution to 10% from 25% for the projects, 'Rain Water Harvesting Phase-1' under SAAP 2015-16 and 'Rain Water Harvesting Phase-I' under SAAP 2016-17.
2. The work to be completed by 31/03/2022
3. Project Manager- Sri. Biju.K, Executive Engineer, Kollam Corporation.

3. Government have examined the matter in detail and pleased to accord sanction to reduce the beneficiary contribution to 10% from 25% for the projects Rain water harvesting Phase I under SAAP 2015-16 and Rain water harvesting Phase I under SAAP 2016-17 subject to the condition that work to be completed by 31/03/2022 by Project Manager - Sri. Biju K., Executive Engineer, Kollam Corporation.
