**ORDER**

As per the orders read as 1st paper above, Government gave AS for Rs.9.34 Cr. for the work of Multi Level Car Parking (MLCP) at Stadium Premises and Bank Road in Urban Transport Sector being implemented by Kannur Corporation and revised the same for Rs.9.96 Cr. as per the order read as 2nd paper above.

2. As per the letter read as 4th paper above, the Mission Director AMRUT has informed that the matter has been placed in the 29th SHPSC for approval and Committee decided as follows:

1. The SHPSC decided to revise the AS of the work to Rs.11.27 Cr. from Rs.9.96 Cr. due to the 18% GST amount (Additional Amount - Rs.1.30 Cr.) subject to the condition that excess amount of Rs.1.30 Cr. shall be met from the savings in AS under the Urban Transport Sector.
2. The work shall be completed by 31/12/2022.
3. Project Manager: Smt. Beena A, Superintending Engineer, Kannur Corporation.

3. Government have examined the matter in detail and are pleased to accord revised administrative sanction for the work "Multi Level Car

Parking (MLCP) at Stadium Premises and Bank Road" in Urban Transport sector being implemented by Kannur Municipality to Rs.11.27 Cr. from Rs.9.96 Cr. due to the 18% GST amount (Additional Amount - Rs.1.30 Cr.) subject to the condition that excess amount of Rs.1.30 Cr. shall be met from the savings in AS under the Urban Transport Sector. The work shall be completed by 31/12/2022 by Project Manager as per the decision of 29th SHPSC for AMRUT dated 04/01/2022.
