ORDER

As per the order read as 2nd paper above, sanction was accorded for the release of an amount of Rs.1,91,39,14,000/- (Rupees One hundred Ninety One Crore Thirty Nine Lakh Fourteen Thousand only) the 4th installment of the Central and corresponding State Share under AMRUT for SAAP I and SAAP III.

As per the O.M. read as 3rd paper above, Ministry of Finance, Government of India and as per Circular read as 1st paper above with the implementation of the Single Nodal Agency (SNA) system, the funds received from the Central Government along with the matching State share shall be transferred to the Single Nodal Account of the Single Nodal Agency and the same shall not be diverted to any Personal Deposits or any other account by the State Government.

As per the order read as 2nd paper above, Government had sanctioned the release of amount into the PSTSB account bearing No. 363, maintained by the Mission Director AMRUT for Centrally Sponsored Schemes with the Sub Treasury, Vellayambalam and transfer credit to the PFMS linked account No. 6424109855 maintained by Mission Director AMRUT in the Indian Bank, Thycaud Branch.

As per the letter read as 4th paper above, the Mission Director, AMRUT has requested to modify the Government Order by allowing to release the amount directly to the Single Nodal Account maintained by the Mission Director, AMRUT with account No. 6424109855 in Indian Bank, Thycaud Branch (IFS Code: IDIB000T021) under the same Head of Account.


