ORDER

As per the O.M. read as 1st paper above, the MoHUA, Government of India, has informed that the extension of the schemes of AMRUT and Swach Bharat Mission (Urban) till the date of consideration of the proposals of Jal Jeevan Mission (Urban) and Swach Bharat Mission (Urban) respectively by the Cabinet. Also informed in the guideline No.15.8 the ongoing AMRUT project will continue to be funded as per AMRUT guideline. As per the minutes of the meeting held on 09.11.2021 by the Hon'ble Minister of LSGD has also decided to continue the State Mission Management Unit and City Mission Management Unit.

2. As per the G.O. read as 2nd paper above, the Government of Kerala accorded sanction to Mission Director AMRUT to continue such as Tripartite Agreement executed with Kerala Water Authority for the implementation of Water Supply and Sewerage Projects and Contract with IRMA for monitoring the implementation of projects from 01/04/2021 to 31/03/2022 and also extend the contract employment of

State Mission Management Unit and City Mission Management Unit and the contract staff appointed by 9 AMRUT Cities, Daily Wage Staff and other contract obligation upto 31/03/2022.

3. As per the letter read as 4th paper above, the Mission Director, AMRUT has informed that Government of India have launched AMRUT 2.0 and the funds will be provided to complete the ongoing AMRUT Projects upto 31.03.2023; and requested to issue orders for enabling the Mission Director AMRUT to continue with service mentioned above, including that the Contract Staffs, daily wage staffs and other contracts for the smooth completion of the ongoing AMRUT projects till 31/03/2023 after which further extension may be considered.

4. Government have examined the matter in detail and are pleased to enable the Mission Director, AMRUT to continue with service including the Contract Staffs, Daily Wage Staffs and other Contracts; for the smooth completion of the ongoing AMRUT projects till 31/03/2023; subject to the condition that an undertaking to be obtained from Contract as well as Daily Wages employees that they will not claim permanency of job in the Department or Mission or Government.
