**ORDER**

As per Government Order read as 1<sup>st</sup> paper above, Government have accorded sanction for the Project "De-centralised sewerage scheme for Thrissur Municipal Corporation" for an amount of Rs.53.4 Crore. Based on the proposal of Thrissur Corporation, 30<sup>th</sup> State Level High Powered Steering Committee held on 05.07.2022, read as 2<sup>nd</sup> paper above, decided to revise the Administrative Sanction to 64.20 crore subject to the following condition:-

- a The additional fund of Rs.10.80 Cr. will be met by the Urban Local Body from the "Nagara Sanchayam Project (Urban Agglomeration Project)" and short comings if any shall be borne by the Urban Local Body.
- b. The work shall be completed by 31.03.2023.
- c. Any financial implication due to in-completion of work by

31.03.2023 shall be borne by the Urban Local Body.

2. Mission Director AMRUT, as per letter read as 3<sup>rd</sup> paper above, has requested to revise the Administrative Sanction for the above said work in tune with the decision of the Committee.

3. Government have examined the matter in detail and are pleased to revise the Administrative Sanction for the work "De-centralised sewerage scheme for Thrissur Municipal Corporation" from Rs.53.40 crore to 64.20 Crore subject to the conditions stated above.
