ORDER

As per G.O read as 1st paper above, administrative sanction was issued to 71 AMRUT projects including sewerage treatment plant for General Hospital Thrissur. The Mission Director, AMRUT, as per the letter read as 2nd paper above, has informed that the proposal of Thrissur Corporation for revising the Administrative Sanction of the Sewerage Sector work namely, "Sewerage Treatment Plant, 360 KLD Capacity, General Hospital, Thrissur" was placed in the 31st SHPSC for approval.

2.The 31st SHPSC held on 27.10.2022 decided to accord sanction to revise the Administrative Sanction of the project, "Sewerage Treatment Plant, 360 KLD Capacity, General Hospital Thrissur" from Rs.3.52 Crore to Rs.4.50 Crore subject to the following conditions:

- i)The excess amount of Rs.0.98 Crores shall be met by the ULB from the Urban Agglomeration Fund of Rs. 1 Crore or from the own fund of the ULB.
- ii)Any financial implications due to non-completion of the work by 31.03.2023 shall be borne by the ULB.

3. The Mission Director, Amrut, has requested that the necessary Government Order may be issued at the earliest based on the decision taken by the 31st SHPSC.

4. Government have examined the matter in detail and are pleased to accord Sanction of the project, "Sewerage Treatment Plant, 360 KLD Capacity, General Hospital. Thrissur" from Rs.3.52 Crore to Rs.4.50 Crore subject to the following conditions:

- 1)The excess amount of Rs.0.98 Crore shall be met by the ULB from the Urban Agglomeration Fund of Rs. 1 Crore or from the own fund of the ULB.
- 2)Any financial implications due to non-completion of the work by 31.03.2023 shall be borne by the ULB.
