## **ORDER**

The Mission Director, Amrut, as per the letter read as 1<sup>st</sup> paper above, has informed that the proposal of Kannur Corporation for revising the Administrative Sanction of the Storm Water Drainage Sector work, 'Construction of New Primary Drains, Secondary Drains and Rejuvenation of Primary Drains" was placed in the 31<sup>st</sup> SHPSC for approval.
