### ORDER

Based on the recommendation of State Level Technical Committee (SLTC), as per the minutes read as 1<sup>st</sup> paper above, 31<sup>st</sup> meeting of the State Level High Powered Steering Committee (SHPSC) of AMRUT has decided to accord Administrative sanction for an amount of Rs. 7 Cr(Seven Crore) for the new work " Providing FHTC to households in Thrissur Corporation Area" subject to the following conditions.

- The required amount shall be met from the available savings in the Water Supply Sector works implemented by Kerala Water Authority (KWA) in Thrissur Corporation under AMRUT-1.0 or from the own fund of the ULB.
- Support & necessary road cutting permissions shall be provided by the Urban Local Body (ULB) to the KWA.
- Any financial implications due to non-completion of the work by 31.03.2023 shall be borne by the ULB.
- Approval of the Council shall be obtained

As per resolution read as 2<sup>nd</sup> above, the Council of Thrissur Municipal Corporation has approved the submission of proposal for the implementation of the new work " Providing FHTC to households in Thrissur Corporation Area" using the available savings in the following Water Supply sector works, for the approval of SLTC/SHPSC
