ORDER

Based on the recommendation of State Level Technical Committee (SLTC), as per the minutes read as 1st paper above, 31st meeting of the State Level High Powered Steering Committee (SHPSC) of AMRUT has decided to accord Administrative sanction for an amount of Rs. 7 Cr(Seven Crore) for the new work "Providing FHTC to households in Thrissur Corporation Area" subject to the following conditions.

- The required amount shall be met from the available savings in the Water Supply Sector works implemented by Kerala Water Authority (KWA) in Thrissur Corporation under AMRUT-1.0 or from the own fund of the ULB.
- Support & necessary road cutting permissions shall be provided by the Urban Local Body (ULB) to the KWA.
- Any financial implications due to non-completion of the work by 31.03.2023 shall be borne by the ULB.
- Approval of the Council shall be obtained

As per resolution read as 2 nd above, the Council of Thrissur Municipal Corporation has approved the submission of proposal for the implementation of the new work " Providing FHTC to households in Thrissur Corporation Area" using the available savings in the following Water Supply sector works, for the approval of SLTC/SHPSC
