ORDER

As per the minutes read above, the State Level High Powered Steering Committee (SHPSC) of AMRUT under the chairmanship of Chief secretary has reviewed the progress of following projects under AMRUT.

- 1. Sewerage projects of Kozhikode Municipal Corporation proposed at Avikkal and Kothi.
 - 2. The weir proposed across Kallada river at Njankadavu as part of the water supply project of Kollam Municipal Corporation under AMRUT.
- 2. The SHPSC has taken the following decisions to ensure timely completion of projects under AMRUT.
 - Necessary actions shall be taken by the ULB and KWA to expedite the progress of works.
 - If there is delay in obtaining decision from Courts the concerned ULBs shall inform the Chief Secretary's office in writing so that the matter can be taken up with the Advocate General.
 - District Collectors shall be made Nodal Officer for AMRUT projects for expediting the execution.
 - 3. Government have examined the matter and are pleased to

authorize, District Collectors as the Nodal Officer for AMRUT projects for expediting the execution for various projects under AMRUT. Urban Local Bodies and Kerala Water Authority shall take necessary action to expedite the progress of works. If there is delay in obtaining decision from Courts, the concerned ULBs shall inform the Chief Secretary's office in writing, so that the matter can be taken up with the Advocate General.
