ORDER

As per G.O read as 1st paper above, Administrative Sanction has been accorded for an amount of Rs.3.65 Cr for the implementation of Water Supply Sector work, "Replacement of existing 525 mm distribution cum pumping main with 600 mm rider pumping main from Karuvelipady to Koovappadam in Kochi Corporation"

- 2. As per the resolution read above, Council of Kochi Municipal Corporation approved the revision of Administrative Sanction of the Water Supply Sector work, "Replacement of existing 525 mm distribution cum pumping main with 600 mm rider pumping main from Karuvelipady to Koovappadam in Kochi Corporation" and the proposal was placed before 31st State Level High Powered Steering Committee (SHPSC) for approval.
- 3. Based on the recommendation of State Level Technical Committee (SLTC), as per the minutes read as 3 rd paper above, the 31st

SHPSC has decided to revise the Administrative Sanction of the work "Replacement of Existing 525mm Distribution cum Pumping Main with 600mm Rider Pumping Main from Karuvelipady to Koovappadam in Kochi Corporation", from Rs.3.65 Cr. to Rs.3.851 Cr., subject to the condition that the work shall be financially completed by 31.03.2023.

- 4. As per the letter read as 4th paper above the Mission Director, AMRUT has requested to accord sanction for the work based on the decision of 31st SHPSC.
- 6. Government have examined the matter and are pleased to accord revised Administrative Sanction for an amount of Rs.3.851 Cr for the work. "Replacement of Existing 525mm Distribution cum Pumping Main with 600mm Rider Pumping Main from Karuvelipady to Koovappadam in Kochi Corporation", subject to the condition that the work shall be financially completed by 31.03.2023.
