# Minutes of the 25th meeting of Apex Committee of Atal Mission for Rejuvenation and Urban Transformation (AMRUT) held on 25.06.2020 under the Chairmanship of Secretary (HUA)

The Joint Secretary and National Mission Director (AMRUT) welcomed Secretary, Ministry of Housing and Urban Affairs, officers from State/ UT Governments and other participants. The list of participants is annexed.

Secretary (MoHUA) congratulated everyone at the outset on the 5th anniversary of Atal Mission for Rejuvenation and Urban Transformation (AMRUT). Secretary (MoHUA) stated that Mission has shown tremendous progress so far. States were also asked to join webinar on 5 years celebration of the mission led by Hon'ble Minister of State for Housing and Urban Affairs.

JS&MD (AMRUT) outlined the agenda for the meeting and presented progress in project implementation.

# Agenda 1. Progress in implementation of AMRUT

Under AMRUT, against the total State Annual Action Plans (SAAPs) of Rs.77,640 crore, contracts have been awarded for projects worth Rs.76,118 crore, including completed projects of Rs.10,654 crore. Further, for projects worth Rs.3,920 crore, Notice Inviting Tenders (NITs) have been issued so far.

#### Discussion

Secretary, (MoHUA) emphasised the need to focus on fast-tracking implementation of projects. On AMRUT reforms, Secretary requested that the 36 cities with A- and above ratings must raise finance through issuance of Municipal Bonds while the remaining cities must work to improve their rating. States of Uttar Pradesh and North-Eastern States were stressed to complete implementation of Online Building Permission System. Further, all States were asked to undertake replacement of pumps identified during Energy audit.

# **Decision of Apex Committee:**

The Apex Committee stated that the progress of the Mission may be expedited in all States/UTs and specifically the States/UTs of Meghalaya, Punjab, Goa, Delhi, Puducherry and Sikkim were asked to award the projects for their balance SAAP amount at the earliest.

#### Agenda 2. Revision of SAAPs of Punjab

The proposal for revision in approved SAAPs of Punjab was considered in this Ministry as per the decision taken in 24<sup>th</sup> Apex Committee meeting. After concurrence of IFD, the approval of the competent authority was conveyed to Govt. of Punjab regarding revision in SAAPs which is subject to ex-post facto approval of Apex Committee.

#### Discussion



Secretary (MoHUA) asked participating Officers from State of Punjab to focus now on expediting the implementation of AMRUT projects. Participating officers from the State of Punjab assured that 95% of its projects will be awarded by 31st July. They further informed that the State will be adopting innovative technology in sewage treatment which is economical in terms of capital cost and also energy efficient.

# **Decision of Apex Committee:**

The Apex Committee approved the proposal for revision of SAAPs by Punjab.

In its 24th meeting on 13.12.2019, Apex Committee granted ex-post facto approval to release a sum of Rs.116.28 crore to 16 States for A&OE under AMRUT for FY 2019-20. Thereafter, with the approval of Secretary (MoHUA) and after fulfilling the criteria laid down under Mission Guidelines, Rs.77.1119 crore has further been released to 11 States/UTs as mentioned below:-

#### Discussion

Secretary (MoHUA) stressed on the need for good urban planning of cities and its impact on livelihood generation. Secretary requested all the Principal Secretaries to ensure preparation of master plans and put it up on a GIS platform.

Secretary (MoHUA) further informed that Ministry can arrange training for Planning Officers at State Planning Department. Secretary requested Joint Secretary & Mission Director (AMRUT) to organize another workshop for LAP/TPS at CEPT University after the pandemic subsides.

#### **Decision of Apex Committee:**

The Apex Committee granted ex-post facto approval to release of fund under A&OE for sub-scheme on "Pilot on Formulation of LAP and TPS" to aforesaid States.



# **Issues raised by States**

Secretary (MoHUA) asked the States to put forward their queries and issues if any.

Various States such as Manipur, Uttar Pradesh, Kerala, Madhya Pradesh and Lakshadweep enquired on their claim for the release of Central Share. Secretary requested the participating Officers form States to take up this discussion with Joint Secretary & Mission Director (AMRUT) and do the needful as advised by her for facilitating early release of the Central Share.

On the request by Meghalaya on handholding support for FSSM projects, Secretary MoHUA) informed the States that they can take assistance from Chief Engineer of CPWD in Meghalaya. Secretary requested Advisor, CPHEEO to co-ordinate with State Mission Directorate and ensure that necessary handholding is provided.

The meeting ended with thanks to the chair.
