Addendum to minutes of 17th meeting of Apex Committee under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) held on 15.03.2017

In the 17th meeting of the Apex Committee held on 15.03.2017, it was proposed that Secretary (UD) may be authorized to approve the SAAP-III of Arunachal Pradesh, Nagaland, Kerala, Andaman & Nicobar Islands, Daman & Diu, Dadra & Nagar Haveli and Lakshadweep in consultation with IFD. The Apex Committee approved the proposal with the advice that Apex Committee may be apprised of such approvals in its subsequent meetings.

2. In accordance with the powers delegated to Secretary (UD) by the Apex Committee and in consultation with IFD, the SAAP-III of the following States/UTs have been approved "in-principle":

3. The final approval will be granted to these States/UTs on achievement of the following conditions precedent to the approval of the SAAP-III:

- i. Projects amounting to at least 25% against SAAP I to be contracted.
- ii. Projects amounting to at least 50% of total approvals (SAAP I & II) to have the DPRs approved.
- iii. 100% of Central fund and corresponding State share against the SAAP-I and SAAP-II to be transferred to the State Mission Directorate/ ULBs/ Parastatals (as the case may be).
- iv. PDMC should have been appointed and be in place.
- v. Regarding credit rating, work must be awarded for all Mission Cities and credit rating targeted to be completed by March 2017.
