Deliberation:

❖ The Committee noted that the fund expenditure of Kollam and Kozhikode Corporation is less compared

to other cities.

- ❖ The Mission Director informed that in the case of Kollam the main reason for less expenditure is due to the delay in commencement of major works like sewer network work of Kureepuzha STP and weir construction at Njankadavu and in the case of Kozhikode the main reason for less expenditure is due to the delay in implementation of the STP and sewer network works envisaged at Kothi and Avikkalthodu.
- ❖ The Managing Director, KWA informed that so far there are no takers for the sewer network work due to the difficulties involved in the execution of works and the weir work is yet to be awarded due to the issues related to the estimate prepared earlier. These works cannot be completed by March-2023.
- ❖ The Superintending Engineer, KWA, Kollam informed that the sewer network work was tendered many times but no bids were received. Hence the estimate has been recast in Price-3.0 and will be tendered soon. The estimate of the weir work has been recast in Price-3.0 by the Irrigation Dept. and as per the recast estimate the Administrative Sanction of the work has to be revised. The proposal for revision of the Administrative Sanction is under scrutiny at the KWA's Head Office.
- The Managing Director, KWA informed that 4 Water Supply Sector works, inclusive of the weir work is having a combined Administrative Sanction. Out of this, one work has been completed and more than 80% physical progress has been achieved for WTP work at Vasoorichira. Hence the possibility of showing these works as a single project and the possibility of obtaining time extension for the works beyond March-2023 may be checked.

Decision: The Committee took note of the progress achieved and directed as follows:

- * Seek approval from the MoHUA for the continuation of the Water Supply works of Kollam.
- ❖ Necessary actions shall be taken by the ULBs and KWA to expedite the works and complete as many works as possible by March-2023.

Agenda Item No.4.1: Kozhikode Corporation – Sewerage & Septage Sector – Price Escalation for 6 MLD & 7 MLD STP Works:

Vide letter no. EG21/43162/21 dated 03.11.2022 and letter dated 29.10.2022, the Secretary, Kozhikode Corporation requested to provide a decision from the Govt. regarding price escalation for the sub-works "Zone-A, Package-A: 7 MLD STP at Avikkal Thodu" and "Zone-A, Package-B: 6 MLD STP at Kothi" of the main work "Construction of Sewerage System in Zone-A" and informed as follows:

- M/s. Seamak Hi-Tech Products, Bangalore, the Contractor for both 7 MLD & 6 MLD STP works has requested for price escalation for both works for extending the contract period.
- The execution of the works has been delayed due to the ongoing public protest and court cases.
- The Core Committee held on 25.07.2022 discussed the matter and directed to work out the difference in amount between the DSR-2016 & DSR-2018.
- The DSR-2016 & DSR-2018 comparison statement prepared (as shown below) was placed in the Core Committee held on 26.08.2022 and the Committee decided to send the same along with the price escalation request of the Contractor to the Govt. with the consent of the Council as the Council can't take a decision in this regard.

Accordingly the matter was placed in the Council held on 18.10.2022 and the Council gave consent (13 Councilors dissented the decision), vide Resolution No. 98 (6 MLD) & Resolution No. 117 (7 MLD), to send the price escalation proposal of the Contractor and the DSR-2016 & DSR-2018 comparison statement to the Govt. for taking appropriate decision.

Deliberation:

Deliberation:

❖ The Managing Director, KWA informed that as per the meeting held with the Hon' Mayor of Thrissur on 23.12.2022, the KWA checked the possibility of commencing the work but DI pipes of 800 mm diameter are not available with KWA at present and the same cannot be procured by March-2023. Hence KWA is not in a position to take up the work under AMRUT-1.0.

Decision: The Committee decided to reject the proposal of the ULB for issuance of Administrative Sanction for the Water Supply work (proposed in AMRUT-2.0) under AMRUT-1.0 as the KWA is not in a position to start the work within March-2023 due to the non-availability of the required DI pipes.

Decision: The Committee decided to recommend the issuance of Administrative Sanction (Rs.73.35 Cr.) for the Water Supply works (2nos. – Rs.15.10 Cr.) and the Sewerage works (3 nos. – Rs.58.25 Cr.), to the SHPSC, subject to the following conditions:

- * The approval of the Council shall be obtained for the new proposals.
- ❖ Out of the required amount of Rs.73.35 Cr., an amount of Rs.24.98 Cr. (Water Supply work − 2nos. & Sewerage work − 2nos.) shall be met from the savings available in the AMRUT works of the Thiruvananthapuram Corporation.
- ❖ The balance amount of Rs.48.37 Cr. (Sewerage work 1no.) shall be met from the fund of Rs.50 Cr., reallocated to the Sewerage & Septage Sector works planned in Thiruvananthapuram Corporation from the cancelled works as per the decision (No.4.1) taken by the 31st SHPSC.
- ❖ Any financial implication due to non-completion of the work by 31.03.2023 shall be borne by the ULB.

Agenda Item No.6: GENERAL

Agenda Item No.6.1: Request for Decision on Works That May Go Beyond March-2023:

Out of 999 works taken up for implementation under AMRUT, 836 works have been completed and the balance 163 works are to be completed. Out of the 163 works, 124 works are expected to be completed by March-2023, 27 works are likely to go beyond March-2023 and 12 works have been cancelled by the 31st SHPSC held on 27.10.2022 as these works are not likely to be started / restarted by March-2023 (out of the 12 works, the Palakkad Municipality requested to revoke the decision taken by the 31st SHSPC regarding one work and allow them to execute the work. The details are shown in the Agenda Item No.4.2).

Apart from the 999 works, the 30th and 31st SHPSCs have accorded permission to take up 18 news works. Out of these 18 works, 12 works are expected to be completed by March-2023, 5 works are expected to go beyond March-2023 and 1 work is to be cancelled (Thrissur Corporation has requested to cancel the work and take up 9 new works for utilizing the fund available due to the cancellation. The details are shown in the Agenda Item Nos.4.3 & 5.2).

For the works that may go beyond March-2023 funding may not be provided by the MoHUA after 31.03.2023 and the funding for such works will have to be borne by the respective ULBs. Out of the 27 works that may go beyond March-2023, 7 works fall under the 'Not Awarded' category and 7 works fall under the 'Not Started' category.

Appropriate decision may be taken by the Committee regarding the funding for the works that may go beyond March-2023 and regarding the continuation of works that may go beyond March-2023 which are falling in the 'Not Awarded' and 'Not Started' categories.

Decision: The Committee decided to recommend the following to the SHPSC:

- ❖ The amount required for the completion of the works that go beyond 31.03.2023 shall be fully borne by the respective ULBs.
- * Regarding the Not Awarded and Not Started works the ULBs shall take necessary action urgently to start the works or to cancel them.
