ORDER

The Mission Director, Amrut, as per the letter read 2nd paper above, has informed that the proposal of Kollam Corporation for transferring the savings of Rs.3.595 Cr. from 3 works to the Sewerage Sector work namely, "Balance Sewer Network", for reducing the financial burden on Kollam Corporation for the work from Rs.22.623 Cr. to Rs.19.028 Cr., was placed in the 32nd SHPSC for approval and the Committee, as per the minutes read as 1st paper above, decided to accord Sanction to transfer the savings of Rs.3.595 Cr., available from the completed Water Supply works (2nos. - Rs.2.243 Cr.) and from the cancelled Storm Water Drainage work (1 no. - Rs.1.352 Cr.), to the Sewerage work, "Balance Sewer Network Work", so that the liability of the ULB can be reduced, subject to the condition that any financial implication due to non-completion of the Sewerage work by 31.03.2023 shall be borne by the ULB.

- 2)The Mission Director, Amrut, has requested that the necessary Government Order may be issued at the earliest based on the decisions taken by the 32nd SHPSC.
- 3) Government have examined the matter in detail and are pleased to accord sanction for transferring the savings of Rs.3.595 Cr., available from the completed Water Supply works (2nos. Rs.2.243 Cr.) and

from the cancelled Storm Water Drainage work (1 no. – Rs.1.352 Cr.), to the Sewerage work, Balance Sewer Network Work subject on the condition that any financial implication due to non-completion of the Sewerage work by 31.03.2023 shall be borne by the ULB.
