### **ORDER**

The Mission Director, AMRUT, as per the letter read 2nd paper  
above, has informed that the Cancellation of 2 works worth Rs.81.2 Cr.  
from AMRUT-1.0 and transfer to AMRUT-2.0 was placed in the 32nd  
SHPSC for approval vide Agenda Item No.4.4.

Works to be Cancelled:

1) Decentralized sewerage scheme for Thrissur Municipal Corporation  
AS Amount: Rs.64.20 Cr., vide G.O. (Rt) No. 1929/ 2022/ LSGD dated  
10.08.2022

Sector: SEW

2) Water Efficient Thrissur Phase-2

AS Amount: Rs.17 Cr., vide G.O. (Rt) No. 1956/ 2022/ LSGD dated  
11.08.2022

Sector: WS

The Committee decided to approve the cancellation of the works,  
“Decentralized Sewerage Scheme for Thrissur Municipal Corporation”  
and “Water Efficient Thrissur Phase-2” and the transfer of the above said  
works, to AMRUT-2.0. Also, it was decided that action has to be  
initiated against the officials who reported that the proposed land falls  
under the "wet land" category, due to which the implementation of the  
sewerage project was hindered. The District Collector may submit report  
on the matter to ACS LSGD.

Government have examined the matter in detail and are pleased to  
accord Sanction for the following as noted below:

ii) “Water Efficient Thrissur Phase-2”

The SHPSC has instructed that action be initiated against the officials who reported that the proposed land falls under the "wet land" category, due to which the implementation of the sewerage project was hindered. District Collector, Thrissur is to submit report to enable action in this regard.
