## Agenda Item No.8.2:ACTION TAKEN REPORT ON THE DECISIONS<br/>OF THE 7<sup>th</sup> SHPSC MEETING OF AMRUT 2.0

#### Agenda Item No.6.5: ADMINISTRATIVE SANCTION FOR 12 MICRO WATER SUPPLY PROJECTS DIRECTLY EXECUTED BY THE ULB APPROVED UNDER 1st and 2nd TRANCHES OF SWAP

**SHPSC Decision:** 

The Committee expressed concern over the slow progress in the micro water supply projects. The Committee instructed the Mission Director to give more importance to the micro water supply projects and to expedite the technical approval processes at the earliest from the notified TS committee formed.

Action Taken:

- The proposed Technical sanction committee meeting for Kothamangalam ULB with 8 micro water supply projects was finalized on 6th of February, 2024 at 11.00am headed by C.E, LSGD.
- The remaining 4 numbers of Micro water supply system with administrative sanction for Panoor ULB (KANNUR) has not been worked out yet in PRICE estimates due to various reasons at the ULB end. The Mission Director has warned the concerned ULB for failure in compliance requirement and advised for a faster action.

#### Agenda Item No.7.3: PROGRESS OF AMRUT 2.0

SHPSC Decision:

- ♦ The Committee reviewed the status of AMRUT 2.0.
- The Committee noted that the progress of micro water supply projects is still lagging behind. The Committee instructed the Mission Director to give more importance to the micro water supply projects and to expedite the technical approval processes by the notified technical sanction committee at the earliest and shall monitor the project progress closely by the AMRUT team and also LSGD. Also, faster decisions need to be adhered to by the technical sanction committee formed for the earlier released G.O/AS no: GO.(Rt) no:1909/2023/LSGD DATED 26/09/2023

Action Taken: (Minutes of the 11th SLTC Meeting is enclosed as Annexure-2)

The 11<sup>th</sup> SLTC has suggested that all the further pending MWSS DPR Works stands temporarily canceled and if any prospective DPR adhering to all requirements are through at later stages can be considered based on the viability with acceptable yield testing and water quality reports suitable to ensure quantity and quality of water from selected sources.

#### Agenda Item No.7.4: <u>APPROVAL OF STATE WATER ACTION PLAN- TRANCHE III- SWAP-3</u> <u>PROPOSALS – SEWERAGE & SEPTAGE SECTOR</u>

#### **SHPSC Decision:**

- The Committee approved the inclusion of 4 proposals worth Rs.149.26 Cr. (Capex: Rs.141.35 Cr. & Opex: Rs.7.92 Cr.) in the SWAP-3
  - Alappuzha Municipality 1 no. Rs.68.00 Cr. (Capex: Rs.64.85 Cr. & Opex: Rs.3.15 Cr.)
  - Kochi Corporation 2 nos. Rs.32.58 Cr. (Capex: Rs.31.63 Cr. & Opex: Rs.0.95 Cr.)
  - Thrissur Corporation 1 no. Rs.48.68 Cr. (Capex: Rs.44.86 Cr. & Opex: Rs.3.82 Cr.)
- The excess amounts required for Kochi Corporation (Rs.5.62 Cr.) shall be met from the unused fund of Palakkad Municipality (Rs.46.19 Cr.). Accordingly, the fund allotment for Palakkad Municipality shall be reduced and the same for Kochi Corporation shall be increased
- The proposed Sewerage projects of Kozhikode Corporation 4 nos. Rs.195.19 Cr. (Capex: Rs.172.07 Cr. & Opex: Rs.23.12 Cr.) were found to have a high cost per household connections by the Committee. The Committee directed KWA to examine the proposals

#### Action Taken:

- **\*** These proposals will be sent to MoHUA after finalization of SWAP 3.
- **\*** Remaining SWAP 3 proposals are to be finalized.
- SWAP-3 proposal for Palakkad is included in this agenda.
- ✤ Comments of KWA regarding the estimate of sewerage projects of Kozhikode Corporation was forwarded to the ULB and reply of the ULB is awaited.

#### Agenda Item No. 7.5: <u>APPROVAL OF STATE WATER ACTION PLAN- TRANCHE III-</u> <u>SWAP-3 PROPOSALS -REJUVENATION OF WATER BODIES</u> <u>AND DEVELOPING GREEN SPACES AND PARKS PROJECTS.</u>

SHPSC Decision:

- The Committee instructed the Chief Town Planner to assess the feasibility of the prominent projects under Water body rejuvenation and Green spaces.
- Subject to the feasibility report, the Committee approved the Tranche 3 of State Water Action Plan for 111 project proposals for Rejuvenation of Water Body submitted by 35 ULBs for an amount of Rs.52.635 Cr (Capex Rs. 50.429Cr. And O & M Rs. 2.206 Cr) and 69 project proposals for parks and green spaces submitted by 58 ULBs for an amount of Rs. 38.495 crore (Capex Rs. 34.37 crore and O & M Rs. 4.125 crore) for submitting before the APEX committee.

#### Action Taken:

- ✤ In compliance, the CTP has assessed the feasibility of prominent projects under WBR and Green Spaces & Parks through their District Officers, mostly referred to in the Masterplan. It was reported in his letter LSGD/PD/20948/2023-TCPB3 dated January 17, 2024, (Annexure –1C) that not all the 111 projects under WBR and 69 projects under Green Space and Parks listed earlier are included in the list of projects recommended by CTP(Planning). In addition, projects outside the earlier list are also included. This matter needs to be consulted with LSGIs concerned wherever necessary.
- **\*** Land availability & technical viability should be ensured before issuing Administrative Sanction.
- Decision of the SLTC-

The Committee instructed the CTP to hand over the recommendations to the M.D. AMRUT by February 5th or at the latest by February 7<sup>th</sup> 2024. It was also directed to assess the projects that were outside the earlier list. The whole process should be finalized by the CTP team and the AMRUT team by February 7<sup>th</sup>.

### Agenda Item No.7.6: ADMINISTRATIVE SANCTION FOR 5 WATER SUPPLY PROJECTS APPROVED UNDER 1st and 2nd TRANCHES OF SWAP

#### **SHPSC Decision:**

- The committee discussed the proposals in detail and accorded administrative sanction for 4 WS projects of Thiruvalla, Trippunithura and Thrissur amounting to Rs.6.9292 Cr. (CAPEX Rs. 6.409 Cr. & OPEX Rs.0.52Cr.).
- ♦ The TS shall be issued by the concerned only after meeting the following conditions:
  - The necessary clearances from the relevant authorities are obtained.
  - The project includes a 5-year Operation & Maintenance plan and only admissible components as per AMRUT guidelines.
  - The Central Assistance for urban development projects should not cover the costs of Operation & Maintenance, Supervision charges, or the Value of land/structures required for the project development. These costs should be borne by the State/ULB fund if they are unavoidable.
- Provisional approval was granted by the Committee for the Proposal from Kattappana amounting to Rs.1.19 Cr. (CAPEX Rs. 1.04 Cr. & OPEX – Rs. 0.15 Cr.), subject to the approval from KIIFB.

#### **Action Taken:**

★ AS has been issued vide Government Order: G.O.(Rt)No.190/2024/LSGD dated 23.1.2024.

# Agenda Item No.7.7:ADMINISTRATIVE SANCTION FOR MICRO WATER SUPPLY<br/>PROJECTS TO BE EXECUTED BY ULB'S OF NILESWARAM<br/>(KASARGOD) AND SREEKANDAPURAM (KANNUR)

#### **SHPSC Decision:**

- The committee reviewed the Micro water supply proposals from Nileswaram and Sreekandapuram and accorded Administrative Sanction for the above 2 Micro water supply projects amounting to 1.555 cr. (CAPEX-1.514 Cr. OPEX- 0.041 Cr.) as recommended by the SLTC.
- The Committee instructed the Mission Director to give more due priority to the Micro Water Supply projects and The TS shall be issued by the concerned technical committee formed only after meeting the following conditions:
  - The project should be Technically feasible and have a reliable water source and yield potential.
  - The need and necessity for provisioning of safe and potable drinking water supply to the Perole ward Nileswaram is highly justifiable, even as the unit cost is slightly on the higher side (for Perole only) but are reasonable as no other judicious sources of drinking water supply exists in the area of concern. Moreover, the proposed drinking water supply project for Nediyanga Swarnadhara scheme of Shreekandapuram is very much justified and is in accordance with AMRUT guidelines.
  - *The necessary clearances from the relevant statute authorities are to be obtained if any by the ULB.*
  - The project includes a 5-year Operation & Maintenance plan and only admissible components as per AMRUT guidelines.
  - The Central Assistance for urban development projects should not cover the costs of Operation & Maintenance, Supervision charges, or the purchase Value of land/ structures required for the project development. These costs should be borne by the State/ ULB fund if they are unavoidable.

#### Action Taken:

★ AS has been issued vide Government Order: G.O.(Rt)No.185/2024/LSGD Dated, 23-01-2024

### Agenda Item No. 7.8: ADMINISTRATIVE SANCTION FOR THE SEWERAGE PROJECT OF KOZHIKODE CORPORATION (SWAP-2)

#### SHPSC Decision:

- The Committee accepted the explanation given by KWA that 60350 people will also be benefited through institutional & commercial connections which is equivalent to 12070 domestic connections apart from the 3128 domestic connections envisaged
- The Committee noted that the cost per household considering all these connections comes to around 1 Lakh
- The Committee decided to accord the Administrative Sanction for the Sarovaram Sewerage Project (Zone-B1) for an amount of Rs.179.29 Cr. (CAPEX: Rs.164.20 Cr. & OPEX: Rs.15.09 Cr.) subject to the condition that the excess amount required (Rs.4.2 Cr.) over the approved SWAP amount shall be met from fund allotted to the ULB in the Sewerage & Septage Sector and balance amount from the floating fund allotted to the ULB.

Action Taken:

AS has been issued vide Government Order: G.O.(Rt)No.55/2024/LSGD Dated, 8-01-2024

Agenda Item No.7.9:ADMINISTRATIVESANCTIONOFREJUVENATIONOFWATERBODY PROJECTSAPPROVED UNDER SWAP-2

#### SHPSC Decision:

- The committee accorded Administrative Sanction for the project under Rejuvenation of Water Body- "Rejuvenation of Koyappal Pond" of Panoor Municipality amounting to Rs.0.41Cr. (CAPEX –0.40 Rs. Cr. & OPEX – 0.01Rs. Cr.)
- The over and above the SAAP amount shall be borne by the ULBs.
- The projects should ensure that the benefits of water body conservation and rejuvenation, including temple pond rejuvenation, reach the public and improve their quality of life. A certificate in this regard shall be provided by the ULB.
- The projects should display an AMRUT project information board on the side of the ponds with details of funding, implementing agency, timeline, etc.

#### Action Taken:

# Agenda Item No.7.10:CANCELLATION OF WATERBODY REJUVENATION PROJECTSAPPROVED UNDER THE 2nd TRANCHE OF SWAP AND<br/>REPLACEMENT WITH NEW PROJECTS

#### SHPSC Decision:

- The Committee instructed for convening a meeting with the ULBs immediately to review the decision for cancelling the proposed projects under SWAP 2.
- Subject to the confirmation from ULBs, the Committee approved the cancellation of 23 projects for Rs. 10.97 crore (Capex Rs. 10.46 Rs.0.51 and O&M Rs. 0.51 crore) and the replacement of 19 projects for Rs. 10.558 crore (Capex Rs. 10.056 crore and O&M Rs. 0.502 crore).

#### Action Taken:

In compliance, the Mission Director, AMRUT, conducted a meeting with the ULBs on 29/12/23. Three ULBs agreed to revoke their previous decision to cancel the proposed project, and four ULBs proposed replacement projects. A revised agenda has been placed in this meeting.

Agenda Item No.7.11: SPECIAL ASSISTANCE TO STATES FOR CAPITAL INVESTMENT 2023-2024-- PART-III -URBAN PLANNING REFORMS

#### **SHPSC Decision:**

The Committee directed the Finance department to submit the list of projects under Special Assistance 2023-24 to the Ministry of Finance, Government of India at the earliest.

#### Action Taken:

✤ List of projects under Special Assistance 2023-24 submitted to the MoHUA and Ministry of Finance, GOI.

#### Agenda Item No.8.3: PROGRESS OF AMRUT 2.0

The total outlay of AMRUT 2.0 for 93 Urban Local Bodies in Kerala is Rs.3495 Cr. with Central Assistance of Rs.1372 Cr. The 4<sup>th</sup> Apex committee meeting had approved the 1<sup>st</sup> Tranche of the State Water Action Plan (SWAP-1) for an amount of Rs.1937.77 Cr. (CAPEX-1842.63, OPEX-95.14)-(CA-743.9227 Cr., State Share-666.278 Cr., ULB Share- Rs.432.4302 Cr.). The 6<sup>th</sup> Apex committee held on 04.01.2023 approved the 2<sup>nd</sup> Tranche of the State Water Action Plan for an amount of Rs.683.082 Cr. (CAPEX – Rs.632.658 Cr. & OPEX – Rs.50.424 Cr.)-(CA-234.401 Cr., State Share-217.577 Cr., ULB Share- Rs. 180.675 Cr.)., inclusive of Special Tranche for Water Body Rejuvenation).

#### 8.3.4: SELECTION OF ADMINISTRATIVE OFFICER & ACCOUNTS OFFICER

The AMRUT Mission requires 1 Administrative Officer and 1 Accounts Officer as part of its supporting staff. These positions are currently vacant and have been advertised in the newspapers. Out of the 18 applications received, 11 candidates (7 for Administrative Officer and 4 for Accounts Officer) were shortlisted and interviewed by the selection Committee headed by the Principal Director, LSGD on 11.01.2024.

The selection Committee has approved the rank list of the eligible candidates, which is attached for reference and approval of the Committee (Annexure-3), for issuing the appointment order by the Mission Director AMRUT

The details of selected candidates are;

- 1. Accounts officer-Salil H, Dilzz, EVRA 111, T C 16/440, Elanjimoodu Lane, Edappazhanji, Thiruvananthapuram 695014.
- 2. Administrative officer-Dr.H. Majeed, 31-B Sree Nagar, Kalippankulam, Manacaud P O, Thiruvananthapuram

#### **11<sup>TH</sup> SLTC-Deliberations & Decisions:**

- The Committee has discussed the status of works in each sector and expressed dissatisfaction over the slow progress towards the Micro Water supply sector. The Committee observed that all the approved 15 Micro water supply projects are awaiting technical sanction for a longer time. The Technical Sanction (T/S) Committee was strongly instructed to expedite the process of issuing the technical sanction on an urgent basis. MD AMRUT has conveyed that quicker action and appropriate decisions will be taken on Micro water supply systems.
- The Committee also observed that there are 37 projects that have not initiated tender procedures even after getting technical sanction and 113 projects that have not been awarded even after issuing NIT. The Committee asked to identify the causes of delay in tendering and awarding. KWA and ULBs were asked to take urgent steps to speed up the progress.
- The DCE KWA stated that water supply projects can be considered as "started" if the Contractor has ordered the pipes after signing the Agreement. Therefore, the actual progress of KWA may exceed the progress shown in the table.
- The Committee noted that there is an inordinate delay in submission of remaining 14 Micro Water supply schemes DPR's due to varied technical and other reasons of mismatch between ULB and hired technical consultancy named CWRDM and few other agencies.
- The committee has also suggested that all the pending MWSS DPR Works stands temporarily canceled and if any prospective DPR adhering to all statutory requirements are through at later stages can be considered based on its viability.
- The committee has decided to form a technical cell to prepare a proposal to provide drinking water to the saline water intrusion zones of Kasargod especially Kanhangad and Neeleswaram ULB'S where the micro water supply is not feasible due to salinity and other water Quality issues. (Technical Team comprising of AMRUT, KWA and other competent members shall

be formed to work on the above issue)

- The committee has suggested a concrete proposal/master plan (by convergence of AMRUT, UIDF and other funds on convergence mode) for a comprehensive scheme for ULBs of Kasaragod district in terms of provision of safe and potable drinking water in the salinity affected regions.
- The long pending micro water supply projects at Wadakkanchery (Trichur) is also discussed and the same shall stand temporarily canceled until further DPR adhering to all statute requirements of yield testing, water quality assessment and stipulated Unit cost are adhered to.

**Decision to be taken:** 

- **\*** The SHPSC may kindly take note of the progress of AMRUT 2.0.
- **\*** The SHPSC may approve the recommendations of the SLTC Meeting.
- **\*** The SHPSC may concur for issuing the appointment order by the Mission Director AMRUT for the selection of Administrative officer& Accounts officer.

## Agenda Item No.8.4:Approval of SWAP-3 Proposals – Sewerage & SeptageSector – Palakkad Municipality:

The proposal of Palakkad Municipality to construct a 30 KLD STP for Palakkad Municipal Complex was placed in the 10<sup>th</sup> SLTC (Agenda No.10.05) and the committee decided as follows:

"The proposal for 30 KLD STP for Palakkad Municipal Complex is deferred. The proposal shall be reworked by the ULB for including the District Hospital as well as a reuse plan for the effluent".

As per the letter dated 27.11.2023 (Letter No. E1-18667/21) the Secretary, Palakkad Municipality has requested approval for the SWAP-3 proposal and has informed as follows:(Annexure 4)

The District Hospital, Palakkad produces nearly 280 KLD sewage. For including District Hospital also in the current proposal, STP with nearly 300 KLD capacity will be required. Sufficient space is not available within the Municipal Office for constructing a STP of 300 KLD capacity. The proposal for constructing a 300 KLD STP for General Hospital has been taken up under KIIFB

The effluent from the STP is planned to be reused for the nearby Kottamaidhanam Park and for gardening purposes within the ULB.

The matter was placed in the 30th SLTC and the committee decided as follows:

The Committee took note of the report submitted by the Secretary, Palakkad and decided to recommend the SWAP-3 proposal worth Rs.0.43 Cr. (Capex: Rs.0.40 Cr. & Opex: Rs.0.03 Cr.) of Palakkad Municipality to the SHPSC for approval for inclusion in SWAP-3.

Rejuvenation of water bodies is a significant component under the Mission and 4% of central project funds are allocated for the purpose along with 1% of funds for development of green spaces & parks.

The total outlay of AMRUT 2.0 for 93 Urban Local Bodies in Kerala is calculated as Rs.3495 Cr. with Central Assistance of Rs.1372 Cr.5% of the total fund is allocated for the purpose of Rejuvenation of Water Bodies and Developing Green Spaces and Parks Projects. (Rs.68.6 Cr.).

255 projects for the rejuvenation of Water Bodies worth Rs.82.354 Cr. (CA- Rs. 34.02 Cr.) under Tranche 2 were submitted and the 6<sup>th</sup> Apex committee held on 04.01.2023 approved the same.

#### SWAP-3 proposal for Rejuvenation of Water Bodies-

111 projects worth Rs. 52.635(Capex Rs.50.429 Cr., O & M Rs. 2.206 Cr) under Rejuvenation of Water Bodies of 35 ULBs were approved by the 7 th SHPSC under Tranche 3. The total Central Assistance comes to Rs. 19.827 Cr. The State share and ULB shares are Rs. 18.035 Cr and Rs.14.773 Cr respectively.

Perinthalmanna Municipality in Malappuram District has now submitted two projects. The total project cost including O & M is Rs. 0.808 (CA- 0.365, SS-0.317, ULB-0.126).

Rejuvenation of water bodies is a significant component of the mission, and 4% of central project funds are allocated for this purpose, along with 1% of funds for the development of green spaces and parks. A special SWAP of 255 projects for the rejuvenation of water bodies worth Rs. 82.354

crore (CA-Rs. 34.02 crore) was submitted, and the 6th Apex Committee held on January 4, 2023, approved the same.

As of now, the Administrative Sanctions for 229 Water body Rejuvenation projects worth Rs.69.319Cr. (CAPEX Rs 64.536 Cr and O&M Rs. 4.783 Cr) have been accorded. The 7th SHPSC accorded the Administrative Sanction for the project "Rejuvenation of Koyappal Pond" of Panoor Municipality for Rs. 0.41 Cr (CAPEX: Rs. 0.40 Cr, O&M: Rs. 0.01 Cr).

Now 3 ULBs (Kanhangad, Eloor & Iritty) have submitted 4 WBR projects amounting to Rs. Rs.1.4 Cr (CAPEX –Rs.1.3144Cr & OPEX- Rs. 0.0856 Cr.) from the remaining approved fund in SWAP 1&2. The excess over the MoHUA portal is Rs 0.4144 Cr and can be met from the cancelled projects.

#### **SLTC Decision:**

- The Chair examined the proposals in detail and instructed the Mission Director, AMRUT to reexamine the DPRs thoroughly before presenting them to the SHPSC.
- The committee accorded in principle sanction for the 4 projects under Rejuvenation of Water Bodies amounting to Rs. 1.4 Cr. (CAPEX –1.3144 Cr. & OPEX - Rs. 0.0856Cr.) subject to the condition that the DPRs are verified thoroughly and recommended by the Mission Director AMRUT:
- ✤ TS shall be issued after ensuring the following;
  - The projects are Geotagged.
  - Other Central/ State fund is not utilized for the project components included in the proposed projects

The SMMU, AMRUT team has verified and submitted for approval. However, the Eloor Municipality still needs to obtain the consent and undertaking from the owners of the ponds.

255 projects for the Rejuvenation of Waterbodies worth Rs.82.354 Cr. (CA- Rs. 34.02 Cr.) were approved by the 6th Apex committee held on 04.01.2023.

14 ULBs have placed their request for the cancellation of 23 projects worth Rs.10.967Cr (Capex-10.460 Cr, O & M - 0.507) which cannot be implemented due to various reasons before the The 7th SHPSC held on14/12/2013 for approval. These projects can be replaced with 19 new Waterbody Rejuvenation proposals of eight ULBs worth Rs. 10.558 Cr. (10.056 Cr, O & M - 0.502 Cr).

The Committee instructed to convene a meeting with the ULBs immediately to review the decision to cancel the proposed projects under SWAP 2. In compliance with the direction, the Mission Director, AMRUT, conducted a meeting with the ULBs on 29/12/23. Three ULBs agreed to revoke their previous decision, and four ULBs proposed replacement projects. Manjeri, Muvattupuzha, and Thiruvalla Municipalities have also given requests to cancel their one project. The new cancellation and replacement proposals are placed below for approval. Others have informed that it is difficult to implement the project due to various reasons.

As per AMRUT 2.0 Guidelines Cl. 6.9.1, the SHPSC will be competent to approve replacement of projects costing up to 10% of the respective tranche of SWAP in admissible project components of AMRUT 2.0. Replacement of projects beyond 10% of the respective tranche of SWAP, if approved by SHPSC, shall be sent to the Apex Committee with proper justification for consideration and approval. The present proposal is well within 10% of Tranche 2 (Rs. 683.07 Cr.).

#### 11<sup>th</sup> SLTC- Deliberations & Decisions:

- The chair expressed strong displeasure and opined that it is not a healthy trend to cancel projects that have been approved by the Chief Secretary and the Apex Committee. The projects should be planned with an eye towards the availability of land, ground conditions, technical soundness, and financial sustainability. In the future, Municipal Secretaries should submit proposals to AMRUT only for projects where unconditional land is available. Strict action will be taken against the defaulting Secretaries.
- The Secretaries should provide an undertaking to the M.D, AMRUT regarding the ownership of the land and in case of religious ponds, get an undertaking from the concerned religious authority that public access should not be denied.
- ◆ The M.D AMRUT shall recheck the DPR of high value projects viz. Sl.No. 5, 11.
- The MD, AMRUT should check the proposals for rejuvenation of S1.4 under Kochi Corporation.
- Subject to above, the following decisions are taken;

The committee decided to recommend the cancellation of 22 projects for Rs.10.914 Cr. (Capex Rs.10.34, O&M Rs.0.574 Cr) and replacement with 18 projects for Rs. 9.834 Cr. (Capex Rs. 9.404 cr. and O& M Rs. 0.430 Cr) to the SHPSC.

#### Action taken:

- The Secretaries have been directed to provide an undertaking to the M.D, AMRUT regarding the ownership of the land and in case of religious ponds, get an undertaking from the concerned religious authority that public access should not be denied. The Secretaries were also warned of severe consequences if they fail to comply with the instructions.
- The SMMU, AMRUT rechecked the DPRs of high value projects viz. Sl.No. 5, 11. and found that the proposals were feasible.
- The MD, AMRUT, instructed the Secretary, Kochi Corporation, to provide ownership of wells (Sl. No. 4) in various divisions proposed for rejuvenation.

#### **Decision** to be taken:

The committee may accord sanction for the cancellation of 22 projects for Rs. 10.914 crore (Capex Rs. 10.34 crore Rs.0.574 O&M Rs. 0.574 crore) and replacement with 18 projects for Rs. 9.834 crore (Capex Rs. 9.404 crore and O&M Rs. 0.430 crore).

#### Agenda Item No.8.8: <u>AMRUT 2.0- -WATER SUPPLY SECTOR –</u> <u>REVISION OF ADMINISTRATIVE SANCTION</u> <u>FOR 16 PROJECTS:</u>

16 proposals from 16 Urban Local Bodies were received for revising the Administrative Sanction of Water Supply projects due to tender excess/ design change/ estimate revision. (Project details are attached as Annexure-5)

#### The following is a summary of the same.

- Eloor and Kalamasseri Municipalities requested Revision of AS due to tender excess above 10%, which requires Government approval. (2 Nos.)
- South Paravur, Muvattupuzha, Thiruvananthapuram, Kollam & Kochi ULBs requested Revision of AS due to design change / Estimate revision (5 Nos.)
- 9 ULBs requested for Revision of AS due to tender excess below 10%.
- **Proposals for which Recommendation of MD KWA is awaited** –5Nos (Pala, Ettumanoor, Thirurangadi, Muvattupuzha Municipalities & Kochi Corporation)
- Proposals from Muvattupuzha does not provide a Council approval. Anticipatory sanction of the Chairman has been received
- The total tender excess amount including GST comes to Rs. 12.102 Cr. The State have to meet Rs. 5.954 Cr. and ULBs have to meet Rs. 6.149Cr.
- As per the prevailing Govt. Order [GO (P)No.16/2017/Fin. Dated 06/02/2017] of Finance Department maximum admissible contract PAC shall be limited to the LMR or prevailing

# DSR + 10% tolerance limit, whichever is lower, only. All the proposals except for the ones from Eloor & Kalamassery complies with the GO. The proposals from the Eloor & Kalamassery Municipalities are currently under verification by the Government.

The Central Government may not fund the tender excess amount if the contract awarded cost is more than the appraised cost. As such the tender excess amount may have to be borne by the State and respective ULB.

The SLTC in its 11<sup>th</sup> meeting decided to recommend to the SHPSC that for AMRUT 1.0 cities, 75% of the amount due to tender excess may be met by the ULB and the balance 25% may be met by the State. For AMRUT 2.0 cities, 50% of the amount due to tender excess may be met by the ULB and the balance 50 % to be met by the State.

#### **SLTC Decision:**

- The Committee accorded sanction to revise the administrative sanction of 16 Water Supply projects subject to the following conditions:
  - For Municipalities, the 50% of the amount due to tender excess may be met by the ULB and the balance 50% by the State.
  - For Corporations, 75% of the amount due to tender excess may be met by the ULB and the balance 25% by the State.
  - The excess amount due to the additional works shall be borne from the savings in SWAP-1 & 2.
- ✤ For the requests with above 10% tender excess, the Committee accorded in principle sanction to the revision of AS subject to the condition that Government approves the tender excess.
- The Committee accorded in principle sanction to revise the AS of the Water Supply project in Muvattupuzha Municipality subject to the following conditions:

- The recommendation of the Managing Director, KWA and approval of the Municipal Council.
- A detailed explanation on the reduction in FHTCs and road restoration to be provided by KWA prior to the next SHPSC.
- ✤ For the 5 proposals without rrecommendation of MD KWA and two proposals without council resolutions, the Committee accorded in principle sanction to revise the AS subject to the recommendation of the Managing Director, KWA and approval of the Municipal Council respectively.

#### Decision to be taken:

- **\*** The SHPSC may approve the recommendations of the SLTC Meeting.
- The SHPSC may approve the recommendations of the SLTC with regard to the tender excess of the works under AMRUT 2.0, that for 9 AMRUT 1.0 cities, 75% of the amount due to tender excess may be met by the ULB and the balance 25% may be met by the State. For AMRUT 2.0 cities, 50% of the amount due to tender excess may be met by the ULB and the balance 50% to be met by the State.
- **\*** The SHPSC may defer the requests from the Pala, Ettumanoor, Muvattupuzha, Thirurangadi & Kochi ULBs due to the lack of recommendation of the MD KWA.

#### Agenda Item No. 8.9: <u>AMRUT 2.0 - SANCTION FOR THE RELEASE OF</u> <u>Rs.10 Cr. UNDER THE REFORM INCENTIVE</u> <u>COMPONENT OF THIRUVANANTHAPURAM</u> <u>CORPORATION:</u>

Urban reforms are one of the components under the AMRUT 2,0 Mission. For the financial year 2023-2024, the Ministry of Housing and Urban Affairs has decided to cover cities with a 0.5 million plus population as per Census 2011 for grant of reform incentives. The milestones specified are 85% coverage of water supply, 60% sewerage coverage, NRW using SCADA/ smart elements and 20% reuse of treated water for the cities with a population of more than 5 lakhs. The milestones and incentives are as follows

In Kerala, 3 cities (Thiruvananthapuram, Kochi and Kozhikode) have a population of more than 5 lakhs as per the 2011 census. Based on that, documents are uploaded by Thiruvananthapuram Corporation proving the coverage of water supply of more than 85%. The scrutiny for the same has been done by MoHUA, and is sanctioned with an amount of Rs. 10 Cr.(Annexure-6) it has been directed to use the incentive for the following purposes only.

• Property Tax Mapping through Drone Based Survey/Other latest technologies.

- Drainage Planning and Water Conservation measures including urban flood prevention.
- Reduction in Non-Revenue Water (Introduction of Smart Elements).
- Mechanized Sewage/Septage cleaning.
- Drinking water outlets in public areas.

The Mission Director, AMRUT has submitted a letter to the Government requesting the release of the amount to the SNA account of AMRUT 2.0. Also, the direction has been given to the Secretary, Thiruvananthapuram Corporation for submitting a proposal including the action plan for the utilization of the reform incentive amount.

#### **SLTC Decision:**

The committee noted the release of 10 Cr as the reform incentive for the year 2023-2024 and directed as follows

- The Finance department shall expedite the process of release of funds to AMRUT and the Mission Director shall follow up with the Government for the release of G.O accordingly.
- The Secretary Thiruvananthapuram Corporation shall prepare and submit proposals at the earliest to AMRUT for the following purposes.
  - 1. Property Tax Mapping through Drone Based Survey/Other latest technologies.
  - 2. Reduction in Non-Revenue Water (Introduction of Smart Elements).
  - 3. Mechanized Sewage/Septage cleaning equipment

#### **Decision** to be taken:

**\*** The SHPSC may approve the recommendations of the SLTC meeting.

# Agenda Item No. 8.10:FORMULATION OF GIS BASED MASTER PLAN<br/>UNDER AMRUT 2.0 - RELEASE OF THE 1st<br/>INSTALLMENT (20% OF THE APPROVED COST)

The Ministry of Housing and Urban Affairs, Government of India have launched the sub-scheme of 'Formulation of GIS based Master Plans for towns under AMRUT 2.0'. Towns with a population above 50,000 are eligible for getting financial assistance under this Scheme. In Kerala, there are 49 cities which meet this criterion duly considering the population in 2021 as suggested by TCPO, GoI. This is a 100% centrally assisted scheme. The Government of Kerala vide G.O (Rt) No.2871/2022/LSGD, Dt: 21.11.2022 .(Annexure-7) have nominated the Local Self Government Department (Planning) as the Nodal Agency and Chief Town Planner (Planning) as the Nodal Officer for the implementation of the sub-scheme of formulation of GIS based Master Plans under AMRUT 2.0.

State Action Plan (SAP) for this Scheme, with proposals for outsourcing the works, was prepared as per the Reform Agenda for the scheme issued by MoHUA, Government of India. The SLTC during the meeting held on 24-12-2022 and SHPSC during the meeting held on 23-01-2023 has approved the SAP and recommended it to the Government of India. The SAP was submitted to TCPO, GoI on 16.02.2023. 49 towns in the State are eligible to get upto a total of Rs 3430 lakhs for Master Plan preparation and Rs 98 lakhs for capacity building.

The MoHUA, Government of India vide Letter No. K-I40I1/59/2023-AMRUT IIA, Dt:28.12.2023 have released Rs. 7,05,60,000/- (Rupees Seven Crore Five Lakh Sixty Thousand only) to Government of Kerala as 1st Installment (20% of the approved cost) for the components of preparation of GIS based Master Plans (Rs. 6.86 Crores) and Capacity Building (Rs.19.60 lakhs) under the Scheme of Preparation of GIS based Master Plans for class II towns with population 50,000-99,999 as per the State Action Plan forwarded to the Ministry of Housing and Urban Affairs, GoI.

In this regard, as per the direction of Director, AMRUT Mission, Chief Town Planner (Planning) vide Letter No. LSGD/PD/23026/2023-TCPB3, Dt:04.01.2024 has requested SMMU to take action to get Rs.7,05,60,000/- (Rupees Seven Crore Five Lakh Sixty Thousand only) released to the Single Nodal Account of AMRUT 2.0 for the Scheme through the HoA 2217-05-192-48 (46) [(Formulation of GIS based Master Plan for Class II towns with a population of 50,000-99,999 under AMRUT 2.0 (100% CSS Scheme)].

#### **SLTC Decision:**

- The Committee took note of the release of Rs. 7,05,60,000/- as the 1st installment of funds (20%) for the components of preparation of GIS based Master Plans for class (tier) II towns with population 50000-99999 as per the State Action Plan and directed as follows.
  - Action Plan for preparation of various thematic layers with defined timelines and output needs to be elaborated towards the preparation of GIS Based Master Plan for the 49 towns. It shall be prepared by the Chief Town Planner, LSGD (planning) and the Mission Director, AMRUT shall ensure the apt preparation of an action plan.

#### **Decision to be taken:**

**\*** The SHPSC may approve the recommendations of the SLTC meeting.

# Agenda Item No. 8.11:AMRUT REFORM INCENTIVES - DISTRIBUTIONTO ULBs

AMRUT 1 Mission envisages improving governance through a set of I I urban reforms by achieving 54 milestones over 5 years (2015-20) which are detailed in the Mission guidelines. These reforms have to be implemented in the Mission cities. The incentive fund will be in addition to the Central Share as allocated annually. Kerala has received reform incentives continuously for the last 4 years. An amount of Rs. 59.82 Cr. has been received as reform incentives.

The Ministry of Housing and Urban Affairs has issued guidelines. (Annexure-8) on the utilization of AMRUT Reforms Incentives and it can be utilized for the implementation of reforms, as ULB share, for new projects and for the capacity building activities. The State High Power Steering Committee (SHPSC) is competent to decide on the use of the incentive amount. The SHPSC is also required to inform the MoUD of the use of incentive funds on projects. An Amount of Rs.47.81 Cr has been released to AMRUT Cities and a balance amount of Rs.12 Cr. has been kept in SMMU. Out of Rs. 12 Cr., Rs.0.70 Cr was utilized for the implementation of Various Reforms (NRSC, Property Tax collection, EESL). The balance amount kept in SMMU is 11.3 Cr. The Ministry of Housing and Urban Affairs has directed to send the UC of the balance amount of the reform incentive by 31.03.2024, otherwise the unutilized funds of the reform incentive may be marked under the project head. The Municipalities of Alappuzha, Palakkad, Guruvayoor and Kannur Corporation has informed that they are facing shortage of funds for ULB share as matching grant (20% of the projects cost is ULB share) and are requested to release the reforms incentive for meeting the fund requirement.

ULB share is one of the admissible components under AMRUT, hence it can be utilized for ULB share.

The details are as follows.

#### 11<sup>th</sup> SLTC:

#### **Deliberations:**

- The Deputy Chief Engineer, Kerala Water Authority has requested to get a share of reform incentive to meet the expenses of support staff for the implementation of AMRUT 2.0 project.
- The Committee observed that the Kerala Water Authority is the major stakeholder and more than 90% of the works are being implemented by them. Hence a portion of the incentive amount may be given to KWA to hire good supporting technical hands for speedy disposal of project initiatives.
- The Mission Director AMRUT informed the committee that, as per the guidelines issued by MoHUA, the salary component of regular employees is an inadmissible component under AMRUT and hence the reform incentive amount cannot be used for salary purposes. The incentive amount can only be used for purposes specified in the reform incentive utilization guidelines.

#### **Decision:**

- The Committee took note of the reform incentive allotment to 4 cities and recommended the same to SHPSC.
- **\*** The committee suggested to work out the possibilities of giving an amount of Rs.50 lakhs as an incentive to KWA for procuring machinery and softwares as part of NRW reduction.
- The Committee also directed to explore the possibilities of providing supporting staff to KWA for the implementation of AMRUT 2.0 works.

#### Action taken:

The proposal from KWA for procuring machinery and software as part of NRW reduction for Rs.50 lakhs is awaited. SMMU is in the process of discussing with MoHUA the feasibility of providing supporting staff to KWA for the implementation of AMRUT 2.0 works.

#### **Decision** to be taken:

- SHPSC may approve the recommendations of the SLTC in allocating the reform incentive.
- SHPSC may approve the release of the Reform Incentive(4.92Cr) to the 4 ULBs as ULB share as follows;
  - Guruvayur Rs. 1.66 Cr.
  - Palakkad- Rs. 0.73 Cr.
  - Kannur- Rs. 1.78 Cr.
  - Alappuzha- Rs. 0.75 Cr.

# Agenda Item No. 8.12:PERMISSION FOR UTILIZING THE REFORM<br/>INCENTIVE FUNDS UNDER AMRUT FOR<br/>IMPLEMENTING LOCAL AREA PLANS (LAP) IN<br/>FIVE CITIES AND OPENING OF SEPARATE<br/>BANK ACCOUNT AT STATE LEVEL &<br/>IMPLEMENTING AGENCIES LEVEL

AMRUT 2.0 has a reform agenda, oriented towards achieving water security in ULBs and improving the delivery of municipal services to the citizens. In order to encourage the ULBs to implement the reforms, AMRUT 2.0 incentivizes the successful implementation of a set of reforms.

There are two types of Reforms. Mandatory reforms and Incentive based Reforms. As per the incentive-based reforms agenda, <u>Reform No.5 - Efficient Urban Planning through Local Area</u> <u>Plans (LAP) and Town Planning Schemes (TPS)</u> will come under the purview of Local Self Government Department (Planning). As per the Reform component, this has to be implemented within 2025-26. This reform aims to assist the States in implementing the Local Area Plans and Town Planning Schemes, thereby promoting improvement in brown-field/ core city areas by increasing land in the public realm and infrastructure improvement in green fields respectively.

As per the Milestone of the reform, (a) Inclusion of necessary legal provisions in relevant acts at the State level and, (b) Finalization of plan/ scheme for Local Area Planning (LAP) and/ or Town Planning Scheme (TPS) in selected ULBs are to be achieved for the compliance. The other criteria for selecting the LAP/TPS proposal are

- (i) the area covered in LAP/ TPS of a city shall be a minimum of 50 hectare
- (ii) the proposal under this should not overlap with the proposal covered under subscheme on LAP/ TPS under AMRUT 1.0 for 25 select cities in the country (ie., Thiruvananthapuram as applicable to Kerala)
- (iii) finalization and approval of LAP and/or TPS scheme in selected ULB

As per the reform component, Incentive Allocation of  $\gtrless$  2 crore for each completed/ approved LAP/ TPS plan in one city will be considered and a maximum up to five cities per State will be incentivized.

In this regard, it was decided to prepare Local Area Plan for 5 cities for claiming the incentive allocation for  $\gtrless$  2 crore per city (ie. Total  $\gtrless$  10 crore for five LAPs). Accordingly, proposals were prepared for Kochi Corporation, Thrissur Corporation, Palakkad Municipality, Kollam Corporation and Kozhikode Corporation respectively. The proposal for preparation of LAP under various themes as mentioned by the districts along with area and tentative estimated cost are as follows:

Preparation of Local Area Plan is one of the reforms under AMRUT and hence the reform incentive funds can be used for Local Area Plan. In view of these, the proposals for the above five cities may be approved and necessary permission may be granted for utilizing the reform incentive funds under AMRUT for implementing Local Area Plans in five cities, thereby promoting improvement in brown-field/ core city areas. The LAP Report along with proposals regarding costing and other expenses required for the above five cities are enclosed herewith as Annexure-9.

In addition, on approval necessary permission may be granted to open a separate bank account (Current/Savings) in the name of Chief Town Planner (Planning) and in the name of Implementing

Agencies [(5 District Offices of LSGD (Planning) i.e Kollam, Ernakulam, Palakkad, Thrissur and Kozhikode Cities] to handle the fund granted for the preparation of Local Area Plan in the Indian Bank, Thycaud Branch where the current SNA account of AMRUT is operational.

#### SLTC Decision:

- \* The Committee approved and recommended the proposals of 5 cities [Kochi Corporation, Thrissur Corporation, Palakkad Municipality, Kollam Corporation and Kozhikode Corporation] to SHPSC for implementing Local Area Plans.
- The committee recommended to SHPSC for granting permission to AMRUT Mission Director to transfer Rs. 158 Lakhs from the AMRUT reforms funds to the Saving Bank Account to be created for the mentioned purpose by the Chief Town Planner (Planning).
- The Committee approved and recommend to SHPSC for granting permission to the Local Self Government Department (Planning) to open a separate bank account (Current/Savings) in the name of Chief Town Planner (Planning) and for Implementing Agencies [(District Offices of LSGD (Planning) i.e Kollam, Ernakulam, Palakkad, Thrissur and Kozhikode Cities] to handle the fund granted for the preparation of Local Area Plan in the Indian Bank, Thycaud Branch where the current SNA account of AMRUT is operational.

#### **Decision** to be taken:

**\*** The SHPSC may approve the recommendations of the SLTC meeting.

# Agenda Item No. 8.13: <u>KERALA URBAN POLICY COMMISSION -</u> <u>APPROVAL TO MEET THE EXPENSES FROM</u> <u>AMRUT REFORMS INCENTIVES:</u>

The Census 2011 had uncovered the fast-paced transition of Kerala into an urban society. Since then, one of the dominant developmental paradigms in the state was urbanization. Accordingly, in 2015, the Government of Kerala created 1 new Municipal Corporation and 28 new Municipalities resulting in having a total of 93 Urban Local Governments in the state. While these new Municipalities were still striving to establish new systems for planning, financing and governing, the repeated episodes of hazards in the form of cyclones, floods and Pandemics exposed the various shortcomings within the Local Administration. Under these circumstances, the Government of Kerala with the support of international agencies such as The World Bank, European Commission, UNEP and other bilateral agencies developed a new strategy to assess various risks and prepare the Local Governments to respond effectively and in an agile manner. One of the key proposals

that found acceptance in the Kerala State Partnership Framework developed by The World Bank and its partners was "strengthening transversal systems for resilience". This provided a strong case for preparing instruments such as an Urban Policy which will address the need for across systems engagements and collaborative processes. In pursuance of this, the Government decided to constitute an Urban Policy Commission and Government Order has been issued (G.O 219/2023/LSGD dated 22.12.2023) (Annexure-10). The Order says that the expenses for the Kerala Urban Policy Commission can be met from the Reforms Incentives of AMRUT, KfW Grant of World Bank funded RKI project based on the decision and approval of SHPSC. It is also informed that the expected cost for the activities of Urban Policy Commission is 4 Cr.

The Ministry of Housing and Urban Affairs has issued guidelines on the utilization of AMRUT Reforms Incentives. The reform incentives utilization guidelines specify the following.

- The incentive amount is an additionality and the States are not required to provide any matching fund.
- The State High Power Steering Committee (SHPSC) is competent to decide on the use of the incentive amount. The SHPSC is also required to inform the MoUD of the use of incentive funds on projects.
- The incentive award can only be used on admissible components of the AMRUT, including new projects, reform implementation and capacity building initiatives.
- The reform incentive can also be used as ULBs share for the projects, but not State share.
- Unutilized funds for Reform incentives will be transferred to Project Fund every year.
- The Ministry also amended Guidelines to permit the State Governments to utilize up to 10% of this reform incentive (subject to a maximum of Rs.50 lakh) for expenditure towards participation in international exposure visits/international conferences as per State Government rules for selected participants from ULBs/State Govt. The SHPSC is competent to approve the selection of events and delegates.

Kerala has received reform incentives continuously for the last 4 years. An amount of Rs. 59.82 Cr. has been received as reform incentives An Amount of Rs.47.81 Cr has been released to AMRUT Cities and a balance amount of Rs.12Cr. has been kept in SMMU. Out of Rs.12 Cr., Rs.0.70 Cr was utilized for the implementation of Various Reforms (GIS based Master Plan, EESL, Software on Professional Tax). The balance incentive amount kept in SMMU is 11.3 Cr.

#### **SLTC Decision:**

The committee directed to earmark an amount of 4 Cr for the activities of Urban Policy Commission and recommended the same to SHPSC.

### **Decision to be taken:**

**\*** The SHPSC may approve the recommendations of the SLTC meeting.

## Agenda 8.14: Utilization of Urban Infrastructure Development Fund (UIDF) for State share of AMRUT 2.0.

AMRUT/SBM projects. State shall however ensure that the loans under UIDF are within the overall permission borrowing limit of the State.

- Further in due consensus to the MOHUA meeting on UIDF headed by Secretary Shri. Manoj Joshi IAS., on 19th of January, it has been clarified that Kerala can further apply up to Rs. 1000 Cr in terms of new projects or ongoing projects
- UIDF aims to supplement the State Government's efforts for Urban Infrastructure Development work implemented through Public/ State agencies/ Municipal corporations.
- In this regard, Kerala state has been tentatively allotted a loan by NHB (National Housing Bank) for Rs.388 Cr. towards various DPR viz. 24 proposals from 20 ULB. It is in the final submission stage.
- Letter No A46020/09/2023- EA/9152793 dated 9/10/2023 from MOUHA, states that for improving utilization funds and to build a pipeline of projects, in addition to the State sector projects, as a one-time dispensation, the State share may be financed from the UIDF in ongoing or ongoing projects as Matching grants to complete various AMRUT projects.

#### SLTC Decision:

- ✤ The Chair directed to submit the list of awarded works in AMRUT 2.0 cities for availing the State /ULB share from the UIDF fund.
- ✤ Following the SLTC meeting, during the discussion held with the Principal Secretary, LSGD, it has been decided to seek loan under UIDF for only the State share of the approved SWAP-1&2 of AMRUT 2.0.
- ✤ The total Capex amount for SWAP 1 & 2 is Rs. 2475.288 Cr, wherein the State share is Rs. 883.855 Cr.

#### **Decision** to be taken:

**\*** The SHPSC may take a suitable decision in this regard.

The system will improve the efficiency and effectiveness of the AMRUT Kerala project monitoring process by reducing the human factor and speeding up the process, resulting in faster information flow across the hierarchy. Overall, the system will enhance the ability to deliver better service to its beneficiaries.

As such, The firm TRAVANSOFT SOLUTION (a Startup registered under Kerala Startup Mission) has been entrusted for developing a Web-based and mobile-based project monitoring system with the following features:

#### 1. Web Application

Dashboard, Data & progress updation and Monitoring, uploading all information of the projects including related documents)

#### 2. Mobile Application

Dashboard, Progress updation from the field, Photo capturing & attaching to the projects, Geotagging, Risk/ issues updation, etc.)

#### 3. Public Web portal

Provides easy access to project-related information and updates to the public.

It will ensure transparency and accountability in project management. They can access project details, Physical and financial progress, Documents, Gallery, etc.

TRAVANSOFT SOLUTION has submitted a Proposal for implementing Web based Project Monitoring System at AMRUT KERALA. Travansoft will provide the necessary faculty for the training, but the institution will need to arrange for the infrastructure and support personnel for the attendees. Technical support will be provided for a period of **12 months** from the completion date of the project. Trainers will also be trained while delivering the product. After the free support period, AMC may be taken for the support.

As per the **GO(Ms)** No.2/2022/SPD dated 05.07.2022, it can be purchased the products/ Services directly costing less than 50 Lakh from the Startups registered under KSTM

The 9th SLTC Meeting observed that, the proposed cost for the implementation and customization of the Project Monitoring system at AMRUT Kerala seems slightly on the higher side. Hence it was suggested to send the proposal to the Kerala Startup Mission (KSTM) for scrutiny of the proposal and finalizing the cost. The 6<sup>th</sup> SHPSC meeting accorded sanction to develop the Project Monitoring system for AMRUT and also to entrust the same with TRAVANSOFT SOLUTION at the cost agreed by the Kerala Startup Mission (KSTM).

The proposal submitted by the TRAVANSOFT SOLUTION was **thoroughly** evaluated by the technical committee **meeting** of Kerala Start up mission in the 53<sup>rd</sup> meeting on 27.1.2024 and approved the proposal for an amount of Rs.13.20 lakhs (**Thirteen lakh and twenty thousand**) exclusive of GST adhering to the following; (Letter No. KSUM/77/2024(2) dated 1.2.2024 is attached as Annexure-11)

- 1) Finalize the scope of work and enter into an agreement with the identified startup
- 2) Perform security auditing of the application developed as per the approved guidelines issued vide GO (MS)No.82019/ITD dated 22.4.2019.
- 3) KSUM would be monitoring the progress of the application development with the department and startup.

#### Decision to be Taken-

- ★ The SLTC may accord sanction to develop the Project Monitoring system at AMRUT Kerala and also to entrust the same with TRAVANSOFT SOLUTION at a total cost of ₹13,20,000.00 excluding GST and other statutory deductions adhering to the following;
  - Finalize the scope of work and enter into an agreement with the identified startup
  - Perform security auditing of the application developed as per the approved guidelines issued vide GO (MS)No.82019/ITD dated 22.4.2019.

# Agenda Item No.8.16:AMRUT 2.0 - TAKING UP OF ALTERNATIVEPROJECTSUNDERSWAP1&2PROJECTSSHIFTED TO AMRUT 1.0:

In order to fully utilize the remaining funds available under AMRUT-1.0, it is proposed to shift the 22 Nos water supply Rs. 131.986 Cr. and 12 Sewerage projects worth Rs. 35.069 Cr. in 9 AMRUT Cities from AMRUT-2.0 to AMRUT-1.0. (List of the projects is attached as Annexure-12). The awarded projects are proposed to be transferred to AMRUT-1.0 from AMRUT-2.0 as per the information given verbally from MoHUA that a period of two years from 31.03.2024 will be given for submission of utilization certificates for ongoing works.

Under AMRUT-1.0, the fund sharing is in the ratio 50%-Central: 30%-State: 20%-ULB, whereas, the fund sharing for AMRUT-1.0 ULBs under AMRUT-2.0 is in the ratio 1/3rd-Central: 1/3rd-State: 1/3rd ULB. Hence the transfer of projects from AMRUT-2.0 to AMRUT-1.0 will be beneficial to the AMRUT-1.0 ULBs.

Further the 6th SHPSC Meeting decided to cancel the allocated funds of Rs. 24.728 Cr. with Iritty and Mattannur Municipalities since a comprehensive scheme is taken up under KIIFB in the said ULBs. Thus, the total gap created by the transfer and cancellation of the project comes to CAPEX, Rs.191.783 Cr.

It is therefore proposed to substitute with new 31 water supply proposals worth Rs. 175.067 Cr. from 19 ULBs. This includes 24 Water supply proposals already admitted in the 10th SLTC for Rs. 145.286 Cr. and additional water supply proposals for 7 ULBs for Rs.29.781 Cr.

The projects were verified by the KWA and recommended as feasible. Feasible projects with land availability, council approvals and recommended by the KWA only are recommended for approval.

The total Central Assistance comes to Rs.71.4685 Cr. The State share and ULB shares are Rs.63.919 Cr and Rs. 50.022 Cr respectively.

Kollam ULB has an allocated fund of Rs. 227.13 Cr. (including floating incentive from SEW fund-Rs.107.13 Cr.). Total funds have been utilized under SWAP 1&2 for 10 WS projects. Hence the requested fund of Rs. 12.40 Cr. for 24X7 WS may be utilized from the remaining fund for Sewerage works for Kollam (Rs. 29.57 Cr.).

#### **SLTC Decision:**

- The Committee decided to recommend the following to the SHPSC subject to the approval of the Apex committee:
  - the replacement of 30 proposals for an amount of Rs.171.6272 Cr. (CAPEX Rs.164.9871 Cr. & OPEX – Rs.6.6401 Cr.)
  - Administrative sanction to the substituted water supply projects for an amount of Rs. 185.409 Cr. (CAPEX- Rs.175.067 Cr. & OPEX- Rs.10.342 Cr.)
  - Based on the request from the KWA, the Committee suggested for considering the project proposal from Maradu Municipality for additional works in Raw water pumping main from Pazhoor pump house in SWAP-3.

#### Action taken:

Further to the SLTC Meeting, KWA has submitted a list of 12 Sewerage projects worth Rs. 35.069 Cr. and 1 water supply project from Palakkad worth Rs. 18.24 Cr. to be shifted from AMRUT 2.0 to AMRUT 1.0 to utilize the funds.

#### Decision to be taken:

- The SHPSC may approve the replacement of 24 water supply proposals for an amount of Rs.162.338 Cr. (CAPEX – Rs.35.069 Cr. & OPEX – Rs.1.838 Cr.) for submitting before the APEX committee for approval.
- The SHPSC may issue Administrative Sanction to the substituted water supply projects for an amount of Rs. 185.409 Cr. (CAPEX- Rs.175.067 Cr. & OPEX- Rs.10.342 Cr.) subject to the approval of the Apex committee.
