ORDER

As per the minutes read as 1st paper above, 32nd SHPSC of AMRUT has decided to accord Administrative Sanction for an amount of Rs.3.98 Cr for the following 5 new works under Water Supply Sector and Urban Transport Sector and Park Sector of AMRUT.

- 1.Rejuvenation of pond -construction of retaining wall at Pallikulam (Water Supply Sector - AS amount : Rs.1 Cr.)
- 2.WET Electrical Works- electrical service connection to smart water meter (Water Supply Sector – AS amount : Rs.0.75 Cr.)
3. Construction of Multi Level Car Parking at Thrissur Corporation Office (Urban Transport Sector - As amount : Rs.0.88 Cr.)
4. Construction of Multi Level Car Parking at General Hospital, Thrissur (Urban Transport Sector - As amount : Rs.1 Cr.)
5. EMS Park (Park Sector – AS amount : Rs.0.35 Cr)

2. 32nd SHPSC has also decided to accorded sanction for the issuance of Administrative Sanction for an amount of Rs. 6 Cr for 3 new works related to Sky Walk under Urban Transport sector as detailed below, subject to the condition that a report shall be obtained by the ULB from the District Development Commissioner regarding the effectiveness of the new works proposed related to the Sky Walk.

1. Supplying and installing of lift and centralized AC for Sky Walk (Urban Transport Sector- AS amount : 2.5 Cr)

2.Work: Side covering and false ceiling work of Sky Walk (Urban Transport Sector- AS amount : 2.5 Cr)

3. Installation of Solar Panel at Sky Walk (Urban Transport Sector- AS amount : 1 Cr

3. As per the minutes read as 2nd paper above, SHPSC has decided to accord Administrative Sanction for an amount of Rs.61 Cr., for the work "Supply and laying of 800 mm DI K9 pipe – 18 Km (Additional CWGM -18.7 Km) from Peechi WTP to OHSR at Thekkinkad Maidhanam, Thrissur under Water Supply Sector of AMRUT"

4. As per the letter read as 3rd paper above, Mission Director, AMRUT has reported that as per the report of District Development Commissioner, only the works related to the installation of lifts (Rs.1.35 Cr., out of Rs.2.5 Cr. mentioned as Sl. No.1 of three new works related to Sky Walk under Urban Transport sector) can be considered for issuance of Administrative Sanction as the same will facilitate the use of the Sky Walk by senior citizens and differently abled people. District Development Commissioner, has also reported that the other works related to the Sky Walk may be taken up after observing footfall data for a sufficient period of time.

5. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the following projects based on the decision of 32nd SHPSC read as 1st paper above

I - Five new works under Water Supply Sector and Urban Transport Sector and Park Sector of AMRUT in Thrissur Corporation

- The required amount of Rs.3.98 Cr. for the above new works shall be met from the savings (Rs.17Cr.) due to the cancellation of the work, "Water Efficient Thrissur Phase-2".
- Any financial implication due to non-completion of the works by 31.03.2023 shall be borne by the ULB.

II – Two new works related to Sky Walk under Urban Transport Sector

- The required amount of Rs. 2.35 Cr for the new works related to the Sky Walk shall be met from the savings (Rs.17 Cr.) due to the cancellation of the work, “Water Efficient Thrissur Phase-2”.
- Any financial implication due to non-completion of the works by 31.03.2023 shall be borne by the ULB

6. Government are also pleased to accord Administrative Sanction for an amount of Rs.61 Cr., for the work "Supply and laying of 800 mm DI K9 pipe – 18 Km (Additional CWGM -18.7 Km) from Peechi WTP to OHSR at Thekkinkad Maidhanam, Thrissur under Water Supply Sector of AMRUT," subject to the following conditions, based on the decision of 32nd SHPSC read as 2nd paper above

- The required amount shall be met from the savings due to the cancellation of the works, “Decentralized sewerage scheme for Thrissur Municipal Corporation” & “Water Efficient Thrissur Phase-2” and from the savings available in the SAAP allocation of the Sewerage & Septage Sector of Thrissur Corporation.
- Any financial implication due to non-completion of the works by 31.03.2023 shall be borne by the ULB.
- The Technical Committee constituted for Sewerage & Septage works of AMRUT-1.0 shall be amended in such a way that the Technical Sanction for the Rs.61 Cr., Water Supply work can be issued through the committee.
