ORDER

The 34th SHPSC has considered the proposal for new Water Supply Sector Work, "WET Upgradation" of Thrissur Municipal Corporation under AMRUT 1.0. Based on the recommendation of 29th SLTC of AMRUT as per the minutes read as 1st paper above, State Level High Powered Steering Committee (SHPSC) of AMRUT-1.0 has decided to accord Administrative Sanction for the new Water Supply sector work, "WET Upgradation", for an amount of Rs.8.58 Cr., subject to the following condition

- The amount required (Rs.8.58 Cr.) shall be met from the savings in the work, "Design, construction & commissioning of the 3 MLD WTP, reservoir and pumping main for Ollukkara Zone"
- Any financial implication due to non-completion of the work by Mar-2024 shall be borne by the ULB
- Approval of the Council shall be obtained.
- 2. As per the letter read as 2nd paper above, Mission Director, AMRUT has requested to accord Administrative Sanction for the new Water Supply Sector work, "WET Upgradation" of Thrissur Municipal

Corporation based on the decision of 34th SHPSC.

- 3. Government have examined the matter and are pleased to accord Administrative Sanction for an amount of Rs.8.58 Cr for new Water Supply Sector Work, "WET Upgradation" of Thrissur Municipal Corporation under AMRUT 1.0. subject to the following conditions,
 - The amount required (Rs.8.58 Cr.) shall be met from the savings in the work, "Design,construction & commissioning of the 3 MLD WTP, reservoir and pumping main for Ollukkara Zone"
 - Any financial implication due to non-completion of the work by Mar-2024 shall be borne by the ULB
 - Approval of the Council shall be obtained.
