ORDER

As per G.O read as 1st paper above, Administrative Sanction has been accorded for 96 Projects for Rejuvenation of Water body approved under SWAP 2 of AMRUT -2.0

- 2. As per G.O read as 2nd paper above, Administrative Sanction has been accorded for another 133 Projects for Rejuvenation of Water body approved under SWAP 2 of AMRUT -2.0
- 3. As per the minutes read as 3rd paper above, the 9th State Level High Powered Steering Committee (SHPSC) has approved the cancellation of nine water body rejuvenation projects amounting to Rs.2.2787 crore (Capex: Rs.2.096 crore, O & M: Rs.0.1827 crore) and authorized the substitution with four new projects amounting to Rs.1.6052crore (Capex: Rs. 1.4752 crore, O & M: Rs. 0.13 crore) subject to the condition that
 - The ULB Secretaries provide an undertaking to the Mission Director of AMRUT regarding land ownership for the substituted projects.
 - For ponds owned by religious authorities, an undertaking must be obtained from the relevant religious authority ensuring that public access is not denied.
- 4. Out of 9 projects cancelled, as the Administrative Sanction has already accorded for 7 projects approved under Tranche II, as per the letter read as 4th paper above, Mission Director has submitted a proposal to cancel the administrative sanction for the following 7 projects amounting to ₹1.9487 crore (Capex: ₹1.786 crore; O&M: ₹0.1627 crore)
